The deadline for reporting is March 31, 2021. You may review your congregation's profile and update lay leader information throughout the year to make sure your contact information, service times, and other important data are current. Up-to-date statistical information is essential for the Synod as it plans current and future ministry efforts. Such information is also critical for determining proper voting representation at conventions (see LCMS Bylaw 1.3.4.3). Your timely completion of the report is appreciated.

State News

On January 25, Kansas Governor Laura Kelly signed Senate Bill 14 into law, extending the State of Disaster Emergency Declaration to March 31, 2021. The State of Disaster Emergency in the state of Kansas began March 12, 2020. In other state news, Kansas now has a <u>vaccine dashboard</u>, which is updated every Monday, Wednesday, and Friday by 12:30 p.m. As of February 1, 6.4% of Kansans had been vaccinated.

LCMS FAQ on COVID 19 Vaccines

The arrival of vaccines has raised questions among Christians. Should you take the vaccine? Are the vaccines related to abortion? Can you get a religious exemption if you don't want to be vaccinated? Synod President Matthew C. Harrison recently released a <u>pastoral letter</u> in which he addresses these concerns and points readers to a "<u>Facts and Considerations</u>" document prepared by the Commission on Theology and Church Relations and LCMS Life Ministry.

President Harrison writes: "[The document] provides a summary of what we know about the COVID-19 vaccines, their relation to the issue of abortion, and what we can (and cannot) say about these matters from the Synod's perspective. I hope it proves useful to you as you wrestle with how to bear Christian witness in this world through your love of both God and neighbor."

District Office: Staying the Course

The latest Shawnee County health order, issued January 28, 2021, extends the order issued last July (Shawnee County Resolution 2020-44), with a few modifications, until February 26. We're proceeding as we have been, with the staff working on site but with the option of working from home; the majority of meetings are being conducted virtually.

District Hosts Planned Giving Advocates Training

On January 15-16, Rev. Philip Krupski and Philip Meinzen from the LCMS Foundation provided training for a handful of new planned giving advocates in the Kansas District. This is the beginning of a partnership between the Kansas District and the LCMS Foundation that will benefit congregations, schools, and ministries throughout Kansas.



The District is partnering with the LCMS Foundation in

response to a 2018 district convention resolution that encouraged district leadership to explore the possibility of bringing planned giving services to Kansas. The timing couldn't be better. Meinzen told advocates during the training that we are at the beginning of the largest wealth transfer from one generation to the next in world history. Planned giving provides people the opportunity to practice good stewardship of their assets, not just their income.

The LCMS Foundation helps individuals consider how they'd like to bless their family and inheritors, limit their tax liability, and provide generously for the work of the Church. Individuals who have been faithfully giving to a congregation and would like to continue to support that congregation in the future have many options, including IRA charitable rollovers and Donor Advised Funds.

Trained advocates in the Kansas District will encourage planned giving and address its role in the practice of good whole life stewardship. Advocates can then connect interested individuals with a staff member of the LCMS Foundation, who can help them set up a Lifetime Plan for Giving.

Several members of the Kansas District staff attended the training and are ready to speak to your congregation or ministry about how planned giving can become an important part of stewardship for your people and a blessing to your ministry. Esther Grants Available

The past year has highlighted many ways in which technology can help congregations carry out their mission. If you have ideas for your ministry that involve technology and could use financial assistance, we encourage you to consider applying for a grant through the Esther 4:14 National Grant Program.

The LCMS Office of National Mission has launched the program to encourage congregations to purchase equipment to meet the challenges of the day. Grants will be awarded based on need, innovative character, and willingness to share discoveries with other LCMS congregations and organizations.

Any congregation or recognized mission of the LCMS that has membership in an LCMS district (U.S. only) may apply for a single grant of up to \$1,500.

Grants can be used for technology (e.g., cameras, mixer boards), end-user equipment (e.g., tablets for shut-ins), software or software subscriptions (e.g., editing software, Microsoft Teams, Zoom pro accounts), training, or other equipment or technologies to meet timely needs.

Life Ministry News

The third annual District Life Conference was held January 22, 2021, at St. John's Ev. Lutheran Church. Instead of joining the annual Rally for Life in downtown Topeka (which was canceled this year for safety and security reasons), attendees heard two presentations by invited speaker Rev. Dr. Peter Scaer of Concordia Theological Seminary, Fort Wayne.

Dr. Scaer, an active participant in Life Ministry activities, surveyed troubling societal trends in his morning session, noting the contrast with the first three books of Genesis. "If we get Genesis 1-3 right," said Scaer, "we have a strong foundation." In his second session, Scaer shared historical developments leading to the *Roe vs. Wade* decision in 1973.



VALUE THEM BOTH

On January 28, the Kansas Senate passed House Concurrent Resolution 5003, the <u>Value Them Both Amendment</u>, by a vote of 28-11. The amendment passed in the House the week prior by a vote of 86-33. It will now go before Kansas voters on the August 2022 primary ballot.

The amendment, if passed, would clarify that the Kansas Constitution does not include a right to abortion and would ensure that the right to regulate abortion remains with the people of Kansas, through their elected state representatives and senators. 
Congratulations to Christ Lutheran School teacher Lori Canfield, recipient of the 2021 KAIRS (Kansas Association of Independent and Religious Schools) Distinguished Lutheran Teacher award. Mrs. Canfield teaches first grade at Christ.

CFLC Recommends: Thank, Praise, Serve, and ObeyRev. Timothy Roth, Children's and Family Life Committee

February's theme for our recommendations is *Worship and Prayer*. I have personally found this area of family life to be a struggle, and I know I'm not alone. Society has increasingly moved toward "entrusting to the experts," and the Church has seen the same. In matters of worship and prayer many parents hand this part of faith formation to pastors and other church workers.

Yet parents, especially fathers, are the head of the home and therefore are responsible for the faith formation of their children. That includes not only the habit of attending the Divine Service regularly but also forming within them the practice of daily worship and prayer. I have often found that it is not that parents don't have a desire to lead their children but they don't know how or believe they aren't capable. That is why I am recommending *Thank*, *Praise*, *Serve*, *and Obey: Recover the Joys of Piety* by Rev. William Weedon.



This easy-to-read book speaks to the importance of and gives meaning to the formation of godly habits in your daily lives. In Chapters 1 and 2, Pastor Weeden talks about developing the habits of sanctifying our homes with God's Word each day and praying daily in the rhythm of life. In these chapters he gives some simple suggestions about how to be intentional in setting time aside to be with your family in worship and prayer. The rest of the book continues to inspire a daily life of devotion, which is a life lived in worship, and nothing is more powerful for the faith formation of our children than to see their parents living a life devoted to Christ.

While forming these habits of piety may be awkward at first, as even Pastor Weedon confesses his own struggle to establish the habit of reading God's Word with his family, they are well worth it for the sake of nourishing and strengthening faith in your family life. In addition to *Thank, Praise, Serve, and Obey* I commend the following additional resources that can aid you in your family life of worship and prayer:

Singing Through the Pandemic: Lent

"Even though I walk through the valley of the shadow of death, I will fear no evil" (Psalm 23:4).

The valley of death is full of suffering, pain, and death itself, swarming all around us. For many, this valley of death involves many factors of suffering: relationship strife, depression, despair, physical exhaustion, burnout, etc. No matter how hard we try to avoid it, sin and death continue to follow us, suffering continues to inflict us, and pain never seems to leave us.



It is natural to fear death and suffering. How can we not fear that which seems to harm us? How can we not fear that which is hard to bear? How can we ever walk through this valley and make it out . . . alive? And yet the psalmist says: I will fear no evil. How? Because of Christ. Only in Christ can we face death without fear. Only in Christ can we walk through suffering and find joy. Only in Christ can we live eternally with Him.

And so, we continue to sing:

Let us ever walk with Jesus, follow His example pure, Through a world that would deceive us and to sin our spirits lure. (LSB 685:1a) Let us suffer here with Jesus and with patience bear our cross. Joy will follow all our sadness; where He is, there is no loss. (LSB 685:2a)

The season of Lent focuses on our Suffering Servant, Jesus. We follow Him to the cross, learning once more how He paid the price for our sins and suffered death in our place. Our walk with Christ through the valley of the shadow of death is a walk of suffering and death, because that is what Christ did for us, and because suffering is what we are called to do as Christians. Christ never promised our lives would be free from it, but He did promise to walk with us through it all, just as He bore temptation for us, endured the scorn and scourging for us, and suffered on the cross for us and for our salvation.

Let us gladly die with Jesus. Since by death He conquered death, He will free us from destruction, Give to us immortal breath. (LSB 685:3)

It is unnatural to have joy while dying. But God has given us this joy in our Baptism through His death and resurrection. To die with Jesus means to mortify "all passions that would lead us into sin." Our Baptism is a daily act of dying to ourselves. We do not live for ourselves but for our neighbor, even though we may suffer to do so. By God's love through the cross and given to us by Word and Sacrament, we are strengthened in our love toward others.

We will continue to sin while living on this side of heaven. And so, we are called to repent during this season of Lent and throughout our entire life here on earth. We know that in Christ death is not the end, for as we follow Him to the cross, we know that He didn't stop there. Christ's victory over death resulted in life eternal and the blessings of forgiveness of sins and salvation for us. Thanks be to God! And so, we sing once more:

Let us also live with Jesus. He has risen from the dead
That to life we may awaken. Jesus, You are now our head.
We are Your own living members; where You live, there we shall be

PartnerPLUS is a fixed-rate term note for those who wish to invest even more into the future of the LCMS and its Christ-Centered ministries.

- Earn 1.75% on amounts up to \$50,000 for the two-year term note and 2.25% on amounts up to \$50,000 for the four-year term note.
- Available to LCMS individuals, organizations, congregations, and Individual Retirement Account investments.
- Minimum of \$500 to get started.

ConnectPLUS is a fixed-rate term note for new LCEF investors who wish to earn a competitive interest rate while investing in the future of the LCMS and its Christ-centered ministries.

- Amounts up to \$50,000 earn a 2.25% interest rate.
- Now available to congregations and Recognized Service Organizations.
- Minimum of \$500 to get started.


