INSTRUCTIONS FOR NAVIGATING CONVENTION BUSINESS

First things first: This workbook should be opened with Adobe Acrobat or Reader. If you aren't seeing some of the features described in these instructions, it may be because you've opened the document with another program.

Basic navigation: On the left side of your document is a Bookmark Pane, which contains links (bookmarks) to the various sections of the workbook. When you click on a bookmark, the Document Pane displays that page. Using the bookmarks will allow you to move quickly through the workbook. (Has the pane disappeared? Look for the little bookmark icon on the far left, right over the paper clip, to bring it back.)

Additional links: Some sections have Index pages with additional links to pages within the section. These links are identified by red underlining. An example:

• In Section 4, Resolutions Index, the title of each resolution is underlined in red and links to the text of that resolution.

Returning to a previous page: When you click on a link in the document, you can't return to the original page, unfortunately. This is where the Bookmark Pane comes in handy. For example, if you finish reading the Bylaws resolution in Section 4 and want to go back to nominee information, just look to the left in the Bookmark Pane and click on the Nomination Index. This is much easier than scrolling back and forth in the document trying to find a page.

CONVENTION KEYNOTE SPEAKER

Rev. Roy S. Askins



The Rev. Roy S. Askins has been the managing editor of *The Lutheran Witness* since January 2020. A 2009 graduate of Concordia Theological Seminary, Fort Wayne, Ind., he was pastor of Trinity Lutheran Church, Livingston, Texas (2009–2015), before serving as director of Communications for the LCMS Asia region of International Mission (2015–2019), during which time he and his family lived in Hong Kong and Taiwan. He and his wife, Eliza, currently live in Edwardsville, Ill., with their seven children who attend St. Paul Lutheran School in Hamel.

Presentation Description

The Lutheran Witness has been published for 140 years. During this time, tremendous change has occurred. And yet, in the midst of such change, the church continues to proclaim, teach, and share God's message of forgiveness, won by Christ on the cross and delivered in Word and Sacrament. Despite great differences, the message has not changed. This presentation will explore how LW has participated in the work of proclaiming, teaching, and sharing this message, and then offer some suggestions for what the future might hold.

Convention Special Standing Rules

- 1 The Special Standing Rules for the Convention will be presented to the 2022 Convention for approval.
- 2 They are included at the front of the workbook for the information and convenience of delegates in the
- 3 event they are adopted.
- 4 1. The chair will see that the agenda is followed as closely as possible.
- 5 2. Resolutions shall be prioritized by floor committees and normally shall be presented to the convention
- 6 in numerical sequence. However, resolutions that impact nominations or elections may be given earlier
- 7 consideration at the discretion of the chair, in consultation with the floor committee chair and the chair of
- 8 the floor committees on nominations and elections.
- 9 3. It shall be the discretion of the chair or presenting member of the floor committee to read the preface,
- 10 preamble, rationale, and whereas sections of resolutions from floor committees that are printed in the
- Workbook Update. In addition, the chair of the convention is not required to read each resolution as he
- states the questions and then as he calls for the vote.
- 13 4. The delegates will consider omnibus resolutions as part of regular scheduled business. Omnibus A
- refers to overtures referred to a board, commission, or other group of Synod to consider and take action.
- 15 Omnibus B refers to overtures that affirm an action previously taken in past conventions. Omnibus C
- 16 refers to overtures declined by the floor committee. Omnibus D refers to overtures of thanks or
- 17 recognition. A majority vote is required to remove an overture from an omnibus resolution and
- have it referred to the appropriate floor committee for action.
- 19 5. If any resolution is not acted upon by the convention before adjournment, it dies and the subject 20 matter may be reintroduced for possible consideration by an overture to the next convention.
- 21 6. When recognized by the chair, members of the convention will state their name, whether they are a voting delegate or an advisory delegate, and the congregation or ministry they represent.
- 7. Voting delegates may speak and vote. All nonvoting advisory delegates may participate in debate, but may not nominate candidates, make motions, or vote. The chair may acknowledge others to speak.
- 25 8. A delegate who has spoken on an issue may not at the close of their remarks move the previous question.
- 27 9. No delegate or representative may speak in debate any longer than two (2) minutes per speech. No
- delegate or representative may speak more than twice on the same motion on the same day and may not
- speak a second time until all delegates and representatives desiring to speak the first time have had the opportunity. The chair shall have discretion to make exceptions to this rule.
- 31 10. Any voting delegate may move to close debate (call the question) when recognized to speak. A vote
- 32 on closing debate (two-thirds vote required) on the pending motion shall be put by the chair after every
- 33 twenty (20) minutes of debate. The chair may also call for a vote on closing debate (two-thirds vote
- required) when in his judgment the assembly has heard sufficient speaking from both sides of the issue.
- 35 (The Pro-Con speakers on a question will be observed at the discretion of the chair.)
- 36 11. Personal Privilege will not be abused by using the time to advance the speaker's opinion. It is only to
- 37 ask a procedure or parliamentary question. Ordinarily, questions of privilege (or point of personal
- 38 privilege) shall be addressed in writing to the chair or his appointee.
- 39 12. All substitute motions and amendments must be presented in written form to the District Secretary.
- 40 Materials should be provided in digital format. (Materials should be sent by e-mail to
- 41 KSDconvention@kslcms.org when possible.)
- 42 13. If a substitute motion is offered and seconded, the presenter will be offered two minutes to provide
- 43 the rationale for offering it, and a member of the floor committee shall be offered two minutes to present
- 44 rationale for why the committee believes the original motion is to be preferred. The convention shall
- decide by majority vote without further debate whether or not to consider the substitute. If the decision is
- 46 in the affirmative and the substitute motion is subsequently adopted, the original motion fails; if the
- 47 substitute motion does not receive favorable action either to consider or to adopt, the original motion is
- 48 again before the house. (This is the so-called "Behnken rule" for dealing with substitute motions.)

- 49 14. The Convention may alter or add to the nominated slates except for the slate for President. A floor
- nomination must be accompanied by written acceptance of nomination from the nominee and a brief
- 51 biographical description of the nominee. Material should be provided in digital format when possible.
- (These are to be sent to the Nominations Committee at KSDconvention@kslcms.org for review of proper credentials.)
- 54 15. During the Convention, the order of elections will be: (1) President, (2) Vice-Presidents, and (3) All other elective positions.
- 16. A majority of all votes cast shall be required for election to all elective offices and elective board positions. Candidates receiving a majority on the first ballot shall be declared elected.
- 58 17. The election of the President will take place by ballot. If no candidate receives a majority of the votes cast, the candidate receiving the fewest votes shall be eliminated on each subsequent ballot until one candidate receives a majority of the votes cast.
- 18. The election of the Vice-Presidents will take place by ballot. If no candidate receives a majority of the votes cast, the candidate receiving the fewest votes shall be eliminated on each subsequent ballot until one candidate receives a majority of the votes cast.
- 19. Upon the election of the regional Vice-Presidents, a final election will take place ranking the Vice-
- Presidents by separate ballots with a simple majority determining the first, second, third, and fourth Vice-Presidents in line of succession.
- 20. Except on the election of the President and the Vice-Presidents, the following regulations will apply:
- 68 Candidates receiving a majority on the first ballot will be declared elected. When a second or succeeding
- ballot is required for a majority, the candidate receiving the fewest votes and all candidates receiving less
- than 15% of the votes cast will be dropped from the ballot, unless fewer than two candidates receive 15% or more of the votes cast, in which case the three highest candidates will constitute the ballot.
- 72 21. Unless covered by these standing rules of the convention, parliamentary procedure will be governed by the most recent edition of *Robert's Rules of Order*.
- 22. Electronic devices will be permitted in the delegate section. Please respectfully turn all electronic
- devices to silent mode. Any phone calls received or made will be outside the convention floor. Not
- 76 responsible for WIFI connections or power source.
- 77 23. No distribution of literature will be allowed in the Manor Conference Center without pre-convention
 78 approval by the office of the District President.



stones "rejected by men but in the sight of God chosen and precious ... being built up as a spiritual house, to be a holy priesthood, to offer spiritual sacrifices acceptable to God through Jesus Christ" (1 Peter 2:4-5); and

WHEREAS, Our citizenship as the baptized is in heaven (Phil. 3:20), and as such, we are called to live according to the Word, not the world; and

WHEREAS, We, as baptized children of God, are members of the royal priesthood, living

WHEREAS, Living according to our baptismal identity is becoming more challenging, as norms and values of our post-Christian culture, many of which are rooted in ideas antithetical to God's Word, exert ever stronger pressure on Christians to think, act, and believe in ways contrary to their God-given identity in Christ; and

WHEREAS, Church membership in the U.S. has continued to decline while the percentage of those claiming no religious affiliation ("nones") has increased (Gallup Poll, March 2021), pointing to a general weakening of Christian identity; and

WHEREAS, Lutherans confirmed in the faith acknowledge in the Rite of Confirmation their intention "to remain steadfast in this confession and church, and to suffer all, even death, rather than fall away from it," yet a recent study of millennials and the church (LCMS, 2017) found that The Lutheran Church—Missouri Synod is retaining only 33% of its young people into adulthood, reflecting general societal trends; and

WHEREAS, Lack of a strong baptismal identity, especially in the context of an increasingly secular culture, is a serious obstacle in our calling to proclaim, teach, and share the Gospel, leaving the baptized ill-equipped to engage in mission and ministry activities; therefore be it

Resolved, That the District and its members prioritize strengthening baptismal identity in the coming triennium, equipping and encouraging the baptized to stand firm in the faith and resist being conformed to the world (Rom. 12:2) and to move forward boldly as the baptized people of God to expand the Kingdom; and be it further

Resolved, That the District promote the use of resources by congregations and schools designed to strengthen habits central to a strong sense of baptismal identity, including faithful worship, reception of the Lord's Supper, prayer, Bible study, home devotions, mutual upbuilding, and living out one's vocation; and be it further

Resolved, That congregations and schools be encouraged to equip the saints in their midst to boldly "proclaim, teach, and share" by providing training and opportunities in evangelism, apologetics, and lifelong discipleship, with the help of Synod and District resources (e.g., *Every One His Witness;* "Shepherding the Strays" re: Vitality module; Mission Field: USA); and be it finally

Resolved, That the Kansas District memorialize the Synod as it gathers at the 2023 LCMS convention recommending adoption of a mission and ministry emphasis consistent with helping Lutheran Christians hold fast to their baptismal identity, as is the case with the Synod's current emphasis of *Making Disciples for Life* (2019 LCMS Res. 4-03).

(Overtures 22-01-06 and 22-01-07)

To Encourage LCMS Kansans to Vote "Yes" for the Value Them Both Amendment

WHEREAS, The Holy Scriptures clearly teach that human beings are created in the image of God, formed and knit together by God Himself in the womb, and therefore prohibit every sort of murder, including abortion (Gen. 1:26-27, 9:6; Ex. 20:13; Jer. 1:5; Ps. 139:16; Is. 49:1, 5; Matt. 5:21-22; Luke 1:41, 44; James 3:9-10); and

WHEREAS, The Fifth Commandment, "You shall not murder," along with the Small Catechism's explanation "not to hurt nor harm our neighbor, but help and support him in every physical need," celebrates God's gift of life; and

WHEREAS, Christians are called "to speak up for those who cannot speak for themselves" (Prov. 31:8-9); and

WHEREAS, We are to "speak the truth in love" (Eph. 4:15) on issues that God's Word has clearly spoken on in the Holy Scriptures, while being careful to "put not our trust in princes" (Ps. 146:3), meaning that we, as a Church, speak to Biblical issues without aligning ourselves to certain parties or candidates; and

WHEREAS, On April 26, 2019, the Kansas Supreme Court effectively ruled in the case *Hodes & Nauser vs. Schmidt* that abortion is a "right guaranteed in the Kansas constitution," thereby removing the legal foundation for all existing laws that permit basic regulations on abortion; and

WHEREAS, Because of the Kansas Supreme Court's April 26, 2019, ruling, and subsequent lower court ruling, April 7, 2021, existing bans on late-term and taxpayer-funded abortion are now in danger of being rendered unenforceable. Furthermore, the ruling already allows violent live dismemberment abortions to continue and threatens these lifesaving limits in the future:

- parental consent for minors seeking abortion
- informed consent, alerting women to potential health risks
- a 24-hour waiting period
- and abortion clinic sanitation and safety standards; and

WHEREAS, In January 2021, the Kansas Legislature passed the "Value Them Both Amendment" by supermajorities, placing it on the August 2, 2022, primary ballot; and

WHEREAS, The "Value Them Both Amendment" would amend the Bill of Rights in the Kansas Constitution to add a new section that reads as follows:

§ 22. Regulation of abortion. Because Kansans value both women and children, the constitution of the state of Kansas does not require government funding of abortion and does not create or secure a right to abortion. To the extent permitted by the constitution of the United States, the people, through their elected state representatives and state senators, may pass laws regarding abortion, including, but not limited to, laws that account for circumstances of pregnancy resulting from rape or incest, or circumstances of necessity to save the life of the mother."; and

WHEREAS, The following statement shall be printed on the August 2, 2022, ballot with the amendment as a whole:

"Explanatory statement. The Value Them Both Amendment would reserve to the people of Kansas, through their elected state legislators, the right to pass laws to

regulate abortion because there is no Kansas constitutional right to abortion or to require the government funding of abortion.

"A vote **for** the Value Them Both Amendment would reserve to the people of Kansas, through their elected state legislators, the right to pass laws to regulate abortion because there is no Kansas constitutional right to abortion or to require the government funding of abortion.

"A vote **against** the Value Them Both Amendment would make no changes to the constitution of the state of Kansas and could prevent the people, through their elected state legislators, from regulating abortion in many circumstances. It would leave in place the newly discovered right to abortion first recognized in 2019."; therefore be it

Resolved, That the LCMS Kansas District in convention encourage all Christians earnestly to pray for elected and appointed officials, that they may carry out their duties faithfully in a manner consistent with God's Word and His will, for the general welfare and benefit of all citizens (1 Tim. 2:1-2); and be it further

Resolved, That the LCMS Kansas District in convention call upon all Christians to be loyal citizens, adhering to the laws of government, insofar as such laws of said governments do not contradict or contravene the eternal and everlasting truth set forth in God's Word (Acts 5:29); and be it further

Resolved, That the LCMS Kansas District in convention reject the *Hodes & Nauser vs.*Schmidt decision as antithetical to the sanctity of life and encourage members of LCMS congregations to seek ways to embrace life and witness faithfully to the confession they hold; and be it further

Resolved, That the LCMS Kansas District congregations be encouraged to use the resources provided by the "Value Them Both" coalition at the website: https://valuethemboth.com/take-action/; and be it further

Resolved, That LCMS Kansas District congregations observe a month of prayer for life during the five Sundays of July 2022 before the August 2, 2022, vote with specific petitions provided to Kansas District congregations by the District President in a timely manner following the June 2022 Kansas District Convention; and be it finally

Resolved, That LCMS Kansans be encouraged to vote "Yes," according to individual conscience and biblical principles, for the "Value Them Both Amendment" on August 2, 2022.

To Encourage Kansas District Congregations to Seek Opportunities to Collaborate and Partner to Enhance Mission and Ministry in the Kansas District

- **WHEREAS**, God calls us to work together for the good of the Church and of our neighbor (Heb. 10:24-25; Ecc. 4:9; 2 Cor. 8:1-7); and
- **WHEREAS**, Scripture provides many examples of the faithful working together (Mark 6:7; Eph. 4:11-13; Acts 6:1-7; Phil 4:14-20); and
- **WHEREAS**, The Lutheran Church—Missouri Synod (LCMS) is itself a large partnership, made up of congregations "walking together" for the sake of the Gospel, united by a common confession; and

- **WHEREAS**, The number of church work graduates in the years ahead is not projected to keep pace with the number of retirements; and
- **WHEREAS**, Collaboration opportunities among like-minded Christians will become more critical in the years ahead as the U.S. population becomes increasingly secular; and
- **WHEREAS**, Resources from The Partnership Project, launched in 2020 to assist congregations that are thinking about, planning, or implementing partnerships, has proven useful in the Kansas District and beyond, helping to facilitate a variety of partnership discussions; and
- **WHEREAS**, Kansas congregations and circuits are developing creative ideas about how to work together (e.g., the T.I.G. Ministry partnership in western Kansas; Circuit 6's "Maintain the Ministry, Grow the Mission" collaboration); therefore be it
- **Resolved**, That LCMS Kansas congregations, schools, and circuits be encouraged to consider ways in which they can be "better together" for the sake of advancing the Gospel in their location; and be it further
- **Resolved**, That the Kansas District identify, refine, and develop resources as needed to support The Partnership Project and encourage use of these resources; and be it finally
- **Resolved**, That the Kansas District missions executive support congregations, schools, and circuits with partnership exploration through presentations, consulting, and circuit visitor training.

To Support LCMS Mission Work in Francophone West and Central Africa

WHEREAS, God has commanded His people to "go therefore and make disciples of all nations" (Matt. 28:19-20); and

WHEREAS, The LCMS Kansas District has supported international mission work in French-speaking Africa since 1997, focusing initially on the country of Guinea, where funds have been sent annually to support missionary work, church planting, mercy care, and other needs; and

WHEREAS, God has blessed the work in Guinea in myriad ways, establishing a foundation for future Gospel outreach through dedicated missionaries and indigenous workers; and

WHEREAS, In 2016, the District transitioned to "Phase 2" of its mission strategy in West Africa in response to a growing need for theological education in the region, providing support for the Lutheran Center for Theological Studies (CLET) in Dapaong, Togo, primarily through tuition funding for Guinean students; and

WHEREAS, The LCMS Office of International Mission recently helped establish two new local CLET seminaries in Guinea and the Congo, responding to a need for well-trained indigenous Lutheran evangelists, pastors, and professors in this Muslim-majority region; and

WHEREAS, LCMS personnel have relocated to the Congo (Central Africa) in response to personnel changes, threats of violence, and emerging opportunities but plan to continue serving French-speaking countries to the north, including Guinea; and

WHEREAS, LCMS mission outreach in West and Central Africa includes important human care efforts through which the love of Christ is shared, including Mercy Medical Teams and Community Health Education; therefore be it

Resolved, That we give thanks to God for the LCMS missionaries now serving West and Central Africa as well as the seminary students and indigenous church workers, with prayers that God would guard their well-being and bless their work in advancing the Gospel in this region; and be it further

Resolved, That the Kansas District continue to support theological education and other mission outreach in West and Central Africa, including Guinea, through the Pentecost Offering and regular contributions to missionaries and related projects; and be it further

Resolved, That the Assistant to the District President for Missions and Stewardship, working with the LCMS Office of International Mission, identify ways to strengthen our collaboration in the region, and be it finally

Resolved, That convention delegates and guests rise and sing the common doxology in thanks and praise to God for His many blessings in the areas of evangelism, church planting, seminary training, mercy work, and missionary care as we mark 25 years of partnership with the Synod in Francophone West and Central Afric

WHEREAS, our Lord and Savior Jesus Christ desires that the Gospel be preached to all who live on earth (Rev. 14:6); and

WHEREAS, Bigotry (the sinful notion that some ethnic groups are inherently superior to others), misunderstanding, and strife are present in the world and experienced in congregations due to our sin; and

WHEREAS, The Lutheran Church—Missouri Synod (LCMS) abhors bigotry and in convention has passed resolutions repudiating all forms of bigotry, prejudice, and discrimination based on ethnicity (see 1992 Res. 3-03 and 2019 Res. 11-04A); and

WHEREAS, Nihilism and other similar theories including Critical Race Theory (CRT) have become common and controversial suppositions in today's world; and

WHEREAS, The Eighth Commandment forbids us to speak falsely of our neighbor and exhorts us to explain everything in the kindest way, and our Lord Jesus teaches us to love our neighbors; therefore be it

Resolved, That the LCMS Kansas District and its members reject any doctrine that teaches:

 One's ethnicity, ancestry, or nationality are inherently superior to the ethnicity, ancestry, or nationality of another.

 Any individual is inherently racist, or oppressive, whether consciously or unconsciously, because of his or her ethnicity, ancestry, or nationality; and be it further

 Resolved, That the circuits of the LCMS Kansas District develop an objective mission and ministry action plan for outreach to diverse communities among us; and be it further

 Resolved, That the congregations of the LCMS Kansas District be encouraged to conduct conversations on ethnicity and diversity to strengthen unity within the congregation; and be it further

 Resolved, That the congregations of the LCMS Kansas District be encouraged to engage members of their communities in these conversations in light of Christ's Gospel; and be it further

Resolved, That the LCMS Kansas District in convention commend those within the District who intentionally proclaim and work to reach out with the Gospel of Jesus to those who are different from themselves in the light of the Great Commission; and be it further

Resolved, That the LCMS Kansas District in convention promote Christ's teaching that we love our neighbors and reject the world view presented by Nihilism, CRT, and similar theories that are contrary to Scripture and counterproductive to true reconciliation of the one human race created in God's image; and be it finally

Resolved, That the LCMS Kansas District memorialize the Synod as it gathers at its 2023 convention to do similarly.

MISSION AND VISION STATEMENTS

Our **mMission** is to support and encourage the members of the District in carrying out the mission Christ has given His Church (Mt. 28).

Our **vVision** is to partner with and connect the workers, congregations and schools of the District with resources to advance God's mission.

PREAMBLE TO THE BYLAWS

We, the members of The Kansas District of The Lutheran Church—Missouri Synod, as redeemed children of God, acknowledge our part in Christ's mission of proclaiming the freedom and forgiveness of God in Christ to all human beings and of providing aid for them in their spiritual and physical needs. We acknowledge that we have bound ourselves together in a common bond of faith based on the Scriptures and the Lutheran Confessions as the members of District and Synod because we recognize the need for helping each other carry out this mission. We need the ministry of fellow Christians so that, with the help of the Holy Spirit, we may grow in faith and be better prepared to participate in Christ's mission both individually and corporately. In order that we may carry out this mission effectively, we, united in the common bond of faith and love, have established these procedures that shall help to strengthen and guide us. Within the framework of these procedures we pledge ourselves to study the Scriptures diligently, to use the Sacraments faithfully, and to solicit the help of the Holy Spirit boldly.

Article II - Organization

1. **Constitution:** The Constitution of The Lutheran Church—Missouri Synod is also the Constitution of The Kansas District. The Bylaws of the Synod are also the primary Bylaws of the Kansas District.

2. **Legal Representation:** The President and Secretary of the District shall sign all official documents of the District in the name of the District.

3. **Membership:** Membership in The Kansas District shall be governed by the Constitution and the Bylaws of the Synod.

4. **Relationship of the District to the Synod:** The relationship of The Kansas District to The Lutheran Church—Missouri Synod shall be governed by the Constitution and Bylaws of the Synod.

5. **District Conventions:** District Ceonventions shall be governed by the Constitution and Bylaws of the Synod and also by the specific articles governing Ceonvention procedure as may be defined in these Bylaws and the District Operations Manual (which includes position descriptions for Convention Floor Committees, District Convention Planning Committee, Election Committee, Nominations Committee, Endorsement of Candidates for District Office, and the like).

6. **District Board of Directors:** The business and financial affairs of The District shall be governed by the Board of Directors. The Board of Directors oversees the implementation of the strategic mission of The District and is responsible to the District convention to equip, enable and encourage congregations to proclaim the Gospel. The Board of Directors is vested with the general management and supervision of the District's business and legal affairs and shall adopt policies and require procedures which assures said management and supervision are effected. Between conventions the Board of Directors shall provide for implementation within the District of decisions of the Synod and District conventions, approve and review progress of work program plans, adopt annual budgets to support work plans, procure and allocate necessary funds for support of Synod and District budgets, review program performance, call or hire District Executive Staff as deemed appropriate, provide review of Executive Staff positions, and administer the District endowment funds and other District—funds.

7. **District Operations Manual:** In addition to the Constitution and Bylaws of the Synod and the Bylaws of the District, a District Operations Manual shall be established and maintained. This Operations Manual shall specify responsibilities of all officers, boards and committees as well as policy statements and operating procedures governing all District functions.

8. **Geographical Regions:** The District shall be divided into geographical regions, each comprised of two (2) or more circuits, by the action of the District Convention. A vice-president and a layperson shall be elected to the Board of Directors from each geographic region and a layperson from each geographic region shall be elected to the District Nominations Committee. The region membership of an individual is determined by the region of the congregation of which he or she is a member.

Article III - Administration

1. Elective and appointive officers shall execute their responsibilities in accordance with Synod By-Llaws. These elective and appointive officers shall be:

- The District President: The District President shall be executed from the clergy roster of Synod and who shall hold membership in a voting congregation member congregation of the District. The District President is the Chief Executive of the District. He shall represent the Synod in the District. He is responsible for implementation of the resolutions of the Synod and the District Conventions. The District President serves the congregations of the District as liaison between the congregations, District and the Synod and provides leadership and vision for the common work of the congregations, District, and District Sstaff. He is responsible as top staff administrator, for oversight of staff carrying out the directives of the Board of Directors. He shall serve as a voting member of the District Board of Directors and is not eligible to be appointed as the Peresiding Oefficer of the Board meetings. The District President also serves as an ecclesiastical supervisor to congregations and professional workers, makes official visits and investigations, and maintains the official roster of workers in the District.
- Vice-Presidents: A District Vice-President shall be elected from each region as provided by Article II, Section 8 of the Bylaws. The Vice-Presidents shall be elected from the clergy roster of the District and have residence membership in a congregation within the region from which elected. The Vice-Presidents shall assist the President in administering the overall program of the District, especially in their regions. They shall succeed to the office of President, in the event the President is unable to serve, in the order designated by the Convention.
- Secretary: The District Secretary shall be elected from the clergy roster of the District and shall hold membership in a voting congregation of the District. The District Secretary is responsible for conducting the nominations process for the elections of President and Vice-Peresidents, facilitating the work of the Nominating Committee, organizing the work of the Elections Committee, and maintaining the District Operations Manual and related guidelines. The District Secretary is responsible for recording and preserving the official record of actions of the District Convention and the Board of Directors
- Treasurer: The District Treasurer shall be appointed by the Board of Directors and is the custodian (d) of all money and legal documents of the District. The Treasurer is assisted by the District staff for accounting and preparation of records. The Treasurer shall be a layperson, a member of a voting congregation of the District and demonstrate skills in finance and accounting. The appointment shall run concurrent with Delistrict Ceonvention, after which reappointment may be granted.
- Circuit Visitors: A Circuit Visitor for each circuit of the District shall be nominated and elected from the clergy roster of the District as prescribed by the Bylaws of the Synod.

The Conference of Circuit Visitors shall assist the District President according to the Bylaws of the LCMS and shall serve as liaison to bringing the needs of congregations to the attention of the District President.

Presiding Officer of Board meetings: The Board of Directors shall appoint a member of the Board to (f) be the Peresiding Officer of the meetings of the Board in consultation with and with the concurrence of the District President. The District President will not normally serve as the Poresiding Oofficer of the Board meetings. In the absence of the Ppresiding Oofficer, the District Ppresident shall assume the role of Ppresiding Oofficer, pro tem.

2. Elective Boards and Appointive Boards, Committees and Commissions shall be:

- The Board of Directors: The Board of Directors shall consist of seventeen (17) voting members elected at the District Convention:
 - I. Seven (7) ordained ministers:
 - a. The District President.
 - b. The Regional Vice Presidents.
 - c. The District Secretary.
 - d. The Chairperson of the Conference of Circuit Visitors.
 - II. Three (3) Commissioned Ministers.
 - III. Seven (7) Laypersons, at least one (1) elected from each region. (Regional members shall have residence membership in a congregation within their region.)

The advisory members advisors of the Board of Directors shall be the District Treasurer and the District Executive Lead Staff.

The Board of Directors shall meet a minimum of four (4) times each year. Additional meetings may be called by the District President. Time and place of these meetings shall be determined by the District President. A majority of members of the Board shall constitute a quorum.

To meet the exigencies of District operations, the Board may meet electronically by telephone conference eall, or vote by written, mailed or electronic ballot pursuant to written notification. Actions taken at such meetings or by written ballot shall have the same effect as those taken at regular meetings of the Board.

Electronic Meetings

- The board may conduct its meetings electronically using audio, video, or internet-based conferencing technologies.
- In such cases, the technology must allow for each board member to fully participate (hear, speak, have or been given access to documents and other materials as appropriate), including the opportunity to vote.
- Members must be given a reasonable opportunity to access the electronic meeting. If a board member does not have access to the technology to be used, arrangements will be made for the member to participate in person by coming to the District Office or other mutually agreed upon location (prior arrangement necessary).
- As with any board, regular or special meeting, minutes shall be kept that record a summary of the major points of discussion and any action(s) taken.
- Allny board members listening or watching shall acknowledge their presence to the meeting. These names, along with the attending board members, shall be recorded in the minutes of the meeting.

Quorum: A majority of voting members of the Board shall constitute a quorum at any properly called or scheduled meeting.

A majority of voting members of the Board shall constitute a quorum at any properly called or scheduled meeting.

Actions Using Electronic Ballot: In situations where board members are not able to meet as described above, the Board may take action by use of electronic ballot (e.g., e-mail, internet-based voting, etc.) provided all voting members of the board cast a vote and the result of the voting is unanimous.

Minutes of previous meetings, including conference calls and the responses to mailed ballots, shall be provided to the members of the Board at least ten (10) days prior to Board meetings.

The agenda for each meeting of the Board shall be prepared by the District President in consultation with the **Executive Council** Executive Committee.

The District Secretary shall serve as secretary of the Board.

- Service Boards: The Board of Directors shall organize the following service boards as described in the District Operations Manual:
 - Board of Missions: The Board of Missions is responsible for planning and implementing evangelism and mission efforts of the District and equipping, encouraging and empowering congregations in their mission and outreach efforts.
 - Board of Education and Youth: The Board of Education and Youth is to foster and promote Christian education in the congregations of the District, so that children, youth, and adults may grow in their faith, knowledge and understanding of God's Word, thereby equipping, encouraging and empowering them to proclaim the Gospel in their lives.
 - Board of Caring Ministry: The Board of Caring Ministry equips, empowers and encourages III. congregations in caring ministry which responds to the special needs of people. It also offers care and support where needed for professional workers of the church.

- IV. Board of Stewardship: The Board of Stewardship encourages the free and joyous activity of the child of God and God's family, the church, in managing all of life and life's resources for God's purposes and fulfilling the responsibilities of the Synod Bylaws section 4.6.
- V. Board of Administration: The Board of Administration provides administrative and support services to the Board of Directors and congregations of the District including accounting, property management, communications, and related services.
- VI. Executive Council Executive Committee: The Executive Council Executive Committee shall include the District President, Presiding Officer of the Board meetings, the Regional Vice-Presidents, the Chairman of the Circuit Visitors, the Secretary, and the Treasurer. The District President shall serve as chairman of the Executive Council Executive Committee. The District Executive Lead Staff, defined as Executive and Professional Staff, are advisory members of the Executive Council Executive Committee shall recommend action to the Board on matters which do not fall within the scope of activities of the Boards listed above. The Executive Council Executive Committee is to serve as the coordinating agency of the Board of Directors for meeting preparation, recommendations for appointments and as a forum for sharing program and budget information with service boards.

VII. Emergency meetings: The Executive Council Executive Committee may act for the Board of Directors in times of emergency between meetings and in all matters delegated to it by specific action or by policy of the Board, including response to legal action. The Executive Council Executive Committee may not perform acts specifically required by statute or by legislation or the Constitution, Bylaws, and resolutions of the Synod that are required to be performed by the agency Board, nor may they overturn actions of the agency Board. All Executive Council Executive Committee actions shall be reported to the Board of Directors. Any member of the Executive Council Executive Council Executive Committee may request full Board action on any matter. Minutes of the Executive Council Executive Committee shall be sent to the Board within two weeks of the Committee Council action. These meetings may be called by the District President, the Presiding Officer of the Board meetings or three members of the Executive Council Executive Committee.

VIII. Salary Review Committee: The Salary Review Committee is responsible to the Board of Directors for recommending salaries for the staff positions of the District and recommending changes in the base figure used for the annual Guideline guidelines for www.orker ccompensation for use by congregations.

<u>VIII-X.</u> <u>President's Council:</u> The President's Council shall consist of the District President, Vice-Presidents, Secretary and Chairperson of the Circuit Visitors. The District President may consult with them on ecclesiastical matters as appropriate.

- (c) The District Nominations Committee.
- (d) One member of the Synod's Committee for Convention Nominations when required.
- (e) The following Service Boards are appointed by the District President in consultation with the Executive Council Executive Committee and approved by the Board of Directors: Board of Caring Ministry, Board of Stewardship, Board of Education and Youth, Board of Missions and the Board of Administration.
- (f) The Standing Committees and Commissions of the Kansas District shall be: The Elections Committee, the Congregational Constitution and Bylaw Review Committee, the District Bylaws and Operations Manual Committee and others described in the District Operations Manual.

Members of these Standing Committees are appointed by the District President and approved by the Board of Directors.

Members of these Standing Committees must be members in good standing of a voting congregation of the Kansas District.

(g) Special Committees shall be such committees as are from time to time necessary for carrying out the duties of the District Service Boards. Members of these committees are appointed by the District President in consultation with the Executive Council Executive Committee and are approved by the Board of Directors.

Members of these committees must be members of a voting congregation of the Kansas District.

3. **Term of Office:**

- (a) The term of office for the President shall be three (3) years. The President shall not serve more than four (4) consecutive terms.
- (b) The term of office for the Vice-Presidents, Secretary, Circuit Visitors, and the Board of Directors shall be three (3) years. None of these officers shall serve more than three consecutive terms.
 - (c) Service of more than one half (1/2) term in any elected office shall be regarded as full term.
- (d)(e) The term of office of the District Nominations Committee shall be three (3) years. Members of the Committee may not succeed themselves.
- (e)(d) The term of office of appointive boards, committees and commissions shall run concurrent with Delistrict Ceonvention. Due to their responsibilities, the District Youth Ministry Team and the Church Worker Conference Planning Committee are exempt from running concurrent with Delistrict Ceonvention.
- (f)(e) Members of District boards and commissions shall be ineligible for reelection or reappointment to the same board or commission after serving three (3) consecutive terms unless otherwise provided in the Bylaws. They may become eligible again for election or appointment to the same office, board or commission after an interval of three (3) or more years. More than one half (1/2) term shall be regarded as a full term.
- (g)(f) Any member of a board or commission who is ineligible for reelection or reappointment may be elected or appointed to another position.
- (h)(g) Members of the District Staff, while eligible for elective office, shall not serve concurrently as staff and elected officers.
- 4. **Accountability of Officers, Boards, Committees and Commissions:** All boards, committees and commissions shall be responsible to the Board of Directors for the discharge of their responsibilities. Officers in general are responsible to the Ceonvention of the Delistrict (Const. XI A 1) and, as regards ecclesiastical supervision, to the President of the District Synod.
- 5. **Holding More than One (1) Elective Office:** A nominated candidate, if elected, may not hold more than one (1) office to which he/she was elected. The individual may be considered for a second office provided it is by official appointment as referenced in LCMS Bylaws 1.5.1.1 2 the Synod Bylaws. Doubtful cases shall be decided by the President of Synod.
- 6. **Succession to the Office of District President:** The Vice-Presidents shall, in the order in which they have been designated by the District Convention, succeed to the presidency in the event the President becomes unable to carry out his duties. Whenever the Board of Directors determines that the President is unable to serve in the capacity because of prolonged illness or disability, the duties and responsibilities of the office of the President shall be assumed by the First Vice-President. The First Vice-President shall remain as the acting President until the Board of Directors determines that the conditions of illness or disability have been removed.

7. Vacancies in Elective or Appointive Office:

- (a) In the event of a vacancy in the office of a Vice_President, a successor shall be appointed by the Board of Directors from the region not represented. A Vice_President so appointed shall be last in the order of succession.
- (b) Vacancies that occur in the office of Circuit Visitor between conventions shall be filled by appointment by the District President.
 - (c) Vacancies in standing committees shall be filled by the District President.

- (d) Vacancies in the other elective or appointed offices or any other board, special committee or commission shall be filled by appointment by the Board of Directors. At least one nominee shall be submitted by the Executive Council Executive Committee. A vacancy in a position of a regionally elected layperson on the Board of Directors shall be filled with an appointee from that region.
- 8. Appointment of Board Chairpersons: The President shall appoint the chairperson of each service board. in consultation with the Executive Council Executive Committee and with the approval of the Board of Directors.

Article IV – Convention Nominations and Elections

- 1. Nominations Committee: There shall be a District Nominations Committee consisting of three (3) ordained ministers (not more than one [1] from the same region of the District), one (1) commissioned minister, and four (4) laypersons, (one [1] elected from each region of the District). These shall be elected at a regular District Convention from the membership of voting congregations. This committee shall propose at least two (2) candidates for each office to be filled at the next District Convention except the offices of President, Vice-President and Circuit Visitor. All incumbents eligible for reelection shall be considered to be nominees. The region membership of an individual is determined by the region of the congregation of which he or she is a member.
- 2. Nominations for District President, Vice-Presidents, Regional Lay Members of the Board of Directors and Circuit
- (a) District President Each congregation shall be entitled to nominate one ordained minister as candidate for District President. Candidates for the office of District President shall be on the clergy roster of Synod. Only three individuals receiving the highest number of nominations, and agreeing to serve if elected, may be listed on the Convention ballot.
- (b) Regional Vice-Presidents Each congregation shall be entitled to nominate from their region one ordained minister from the clergy roster of the District and who shall have residence membership in a congregation within the region from which nominated. Ceandidates on the ballot for Vice-President from each region, shall be all those having been nominated more than a single nomination and who agree to serve if elected. In the event of death, declination, or unavailability of any candidate, the nominee having the next highest number of votes shall become a candidate. In the event of a tie for the final candidate position, all names involved in the tie shall be included as candidates.
- (c) Regional Lay Members of the Board of Directors Each congregation shall be entitled to nominate two lay members who are members of a congregation in the respective region as a candidate for regional lay member of the Board of Directors. All nominees for lay members of the Board of Directors shall hold residency within the respective region from which they are nominated. Candidates shall be at least the two lay members in the region who receive the greatest number of nominations and agree to serve if elected. All candidates not elected shall be on the ballot for the at large lay positions on the Board of Directors.
 - (d) Circuit Visitor The selection of Circuit Visitor will follow the process detailed in the Synod Handbook.
- (e) District Secretary Each congregation or individuals (rostered workers and individual members of congregations) may nominate one pastor who is on the clergy roster of the District and holds membership in a voting congregation of the District.
- (f) At-Large Lay Members of the Board of Directors Lay members not designated by region may be nominated by congregations, rostered workers, or individual members of congregations.

32. Elections:

- (a) The Convention may alter or add to the nominated slates except for the slate for President. A floor nomination must be accompanied by written acceptance of nomination from the nominee and a brief biographical description of the nominee. Material should be provided in digital format when possible.
- (b) During the Convention, the order of elections will be: (1) President, (2) Vice-Presidents and (3) All other elective positions.
- (c) A majority of all votes cast shall be required for election to all elective offices and elective board positions. Candidates receiving a majority on the first ballot shall be declared elected.
- (d) The election of the President will take place by ballot. If no candidate receives a majority of the votes cast, the candidate receiving the fewest votes shall be eliminated on each subsequent ballot until one candidate receives a majority of the votes cast.
- (e) The election of the Vice-Presidents will take place by ballot. If no candidate receives a majority of the votes cast, the candidate receiving the fewest votes shall be eliminated on each subsequent ballot until one candidate receives a majority of the votes cast.

- (f) Upon the election of the regional Vice-Presidents, a final election will take place ranking the Vice-Presidents by separate ballots with a simple majority determining the first, second, third and fourth Vice-Presidents in line of succession.
- (g) Except on the election of the President and the Vice-Presidents, the following regulations will apply: Candidates receiving a majority on the first ballot will be declared elected. When a second or succeeding ballot is required for a majority, the candidate receiving the fewest votes and all candidates receiving less than 15% of the votes cast will be dropped from the ballot, unless fewer than two candidates receive 15% or more of the votes cast, in which case the three highest candidates will constitute the ballot.

Article V - Conventions and Conferences

1. District Conventions:

- (a) The regular Convention of the District is held in the year immediately preceding the general Ceonvention of the Synod. Only the Synod has the right to make an exception to this rule. Each of the parishes/congregations of the District (a multi-congregation parish being considered as a congregational unit) shall be represented by one (1) pastor and one (1) lay delegate duly elected by the congregation at least one hundred fifty (150) days prior to the Convention. Congregations of a multi-congregation parish not contributing a lay voter may send an advisory representative delegate, with voice but no vote (Syond Bylaw 3.1.2.1[e]) according to the Synod Bylaws.
- (b) The vote at all District Conventions shall be restricted to the duly elected and certified voting pastors and lay delegates of the congregations. Multi-congregation parishes shall determine the voting lay delegate who shall represent all congregations of that parish. If a congregation or parish has more than one called pastor who is eligible to vote, the congregation shall designate which pastor will cast a vote on behalf of the congregation.
- (c) The District Convention shall be conducted in accordance with the Synod Handbook. Matters for consideration by the Convention shall be presented by overture submitted by a member congregation of the District, the District Board of Directors, an official District conference of ordained and/or commissioned ministers, a committee established by a prior convention, or a forum of a circuit. Resolutions for consideration by the Convention shall be brought to the floor of the Convention by appointed Floor Committees.

2. District Ordained and Commissioned Minister Conferences:

- (a) Official Conferences:
 - I. District-wide Ordained Ministers- Conferences shall be held at least once each year.
 - II. District-wide Commissioned Ministers² Conferences shall be held at least once each year.
- III. In the odd numbered years the Ordained Ministers² Conference and Commissioned Ministers² Conference shall be held at the same time and in the same city so that both Conferences shall be enabled to meet together in joint session at least part of the time. Exceptions may be made by the District President in consultation with the President's Council.
 - (b) General Regulations:
- I. Travel, meals, housing and other expenses for professional workers attending official conferences shall be borne by the congregations of the Ordained Mministers and Commissioned Mministers involved.
- II. All Ordained Ministers! and Commissioned Ministers! Conferences shall be governed by the regulations stated in the Bylaws of the Synod.
- III. All Ordained and Commissioned Meministers on the District rosters are expected to attend the meeting of their official conference or present a valid excuse.
- 3. **Visitation Circuit Forums:** The congregations of a visitation circuit, represented by a pastor and one lay<u>person member</u> of each <u>member</u> congregation <u>or one layperson from a multi-congregation parish as designated by the congregation or parish. Congregations of a multi-congregation parish not contributing a lay voter may send an advisory representative, with voice but no vote (Synod Bylaw 5.3.2), shall meet in circuit forums at least once triennially to select Circuit Visitors (Synod Bylaw 5.2.2), to participate in the triennial process of suggesting mission and ministry emphases to the District Convention (Synod Bylaws 5.3.4, 5.3.1[b], 4.2.1[b]), and to consider submitting other overtures to the District or Synod Convention (Synod Bylaws 3.1.6.2) as described in the Synod Bylaws. In addition,</u>

the forum is encouraged to meet at least two times a year to carry out other functions as described in <u>the Synod Bylaws</u> 5.3.1 and to pursue other interests deemed important such as lay leadership development, teacher training, and participation under existing District policy in future local mission development. <u>Congregations of a multicongregation parish not contributing a lay voter may send an advisory representative delegate with voice but no vote, according to the Synod Bylaws.</u>

- 4. **Electoral Circuit Meetings:** The congregations of a visitation circuit or two adjacent visitation circuits (Synod Bylaw 3.1.2 [a]) shall meet once triennially to carry out the responsibility of electing delegates to the general convention of the Synod and to consider sending overtures to the Synod convention, according to the Synod Bylaws (Synod Bylaw 3.1.6.2).
- 5. **Circuit Convocations:** Circuits of The Kansas District may hold Circuit Convocations in the year following the Synodical convention. Joint convocations of Circuits may be held among Circuits. The purpose of the Circuit Convocation is to provide a setting in which congregational members may review and discuss the work of the Circuit Forum, and may receive information on various phases of the work pursued through Districts and the Synod. Its emphasis will be on inspiration, education and motivation.

Article VI – Property

This corporation shall have power to acquire by gift, grants, demise, devise, bequest, purchase, or otherwise, property of every kind and description, real, personal, or mixed; to hold and use such property and deal with, or dispose of, any or all such property by sale, exchange, or gift, when necessary or expedient to carry out the objectives of the corporation; provided that all such property shall be acquired, dealt with, or disposed of in a manner not in conflict with the laws of the State of Kansas or the laws of any state in which said property is located.

Article VII - Amendments and Changes

Changes in these Bylaws and additions thereto may be made provided they are not contrary to the Constitution, Bylaws, and resolutions of the Synod, have received prior approval of the Synod's Commission on Constitutional Matters, are presented to the congregations of the District at least thirty (30) days prior to the time they are presented for vote, are separately considered and acted upon, and are passed by a majority of the voting delegates at a District Ceonvention.

The District in Ceonvention may vote to amend its Articles or Bbylaws provided the resolution is contingent on approval of the Commission on Constitutional Matters. The amended Articles or Bbylaws become effective immediately upon, and only upon, approval of the Commission on Constitutional Matters. Should the Commission on Constitutional Matters not approve the adopted changes, the District Board of Directors may modify amendments to comply with the Commission on Constitutional Matters requirements upon their two-thirds vote.

Article VIII - District Operations Manual

Changes to the District Operations Manual which do not affect the Bylaws of the District shall be reviewed and approved by the Board of Directors. The Board of Directors may not adopt any proposed cenages to the District Operations Manual that are contrary which require changes to the Bylaws of the District. shall require approval of the Board of Directors and adoption by the District Convention.

Appendix A

Summary of Proposed Changes to the Kansas District Bylaws

Resolution 22-02-01 asks delegates to approve changes to the Kansas District Bylaws. The proposed changes have been approved by the Kansas District Board of Directors, and with the exception of the proposed reformatting, have been reviewed and approved by the LCMS Committee on Constitutional Matters (CCM). The revisions fall into four categories.

Revision responding to changes in Synod Bylaws (2019 convention)

The two main changes here concern membership in a region and multi-congregation parishes. Concerning membership in a region, see lines 388-390, which correspond to Synod Bylaw 4.3.1: "The region membership of the individual is determined by the region of the congregation of which he or she is a member." Concerning multi-congregation parishes, see lines 488-489, which correspond to Synod Bylaw 3.1.2.1 (c): "Congregations of a multi-congregation parish not contributing a lay voter may send an advisory lay delegate, with voice but no vote, according to Synod Bylaws."

Revisions responding to CCM suggestions

Many of the revisions respond to comments from the CCM that were sent to the district after a proposed revisions had been reviewed. One example: Changing "Executive Council" to "Executive Committee," per CCM recommendation.

Clarification of district procedures

Changes in this category, initiated by the district, include, e.g., clarifications about the nominations process (Article V).

Style revisions to improve consistency and readability

The most noticeable change in this category is the proposed reformatting of the district bylaws. (See Appendix B for a clean, reformatted version of the proposed bylaws). The proposed new format, approved by the Kansas District Board of Directors in May 2022, follows the example of the LCMS Handbook.

The reformatted version also contains several <u>underlined</u> insertions, all of which respond to comments from the CCM in its most recent communication to the district, which the district received after Floor Committee 2 (Teach) approved Resolution 22-02-01. The changes have been approved by the Kansas District Board of Directors and now come before the convention for approval.

PREAMBLE

We, the members of The Kansas District of The Lutheran Church—Missouri Synod, as redeemed children of God, acknowledge our part in Christ's mission of proclaiming the freedom and forgiveness of God in Christ to all human beings and of providing aid for them in their spiritual and physical needs. We acknowledge that we have bound ourselves together in a common bond of faith based on the Scriptures and the Lutheran Confessions as the members of District and Synod because we recognize the need for helping each other carry out this mission. We need the ministry of fellow Christians so that, with the help of the Holy Spirit, we may grow in faith and be better prepared to participate in Christ's mission both individually and corporately. In order that we may carry out this mission effectively, we, united in the common bond of faith and love, have established these procedures that shall help to strengthen and guide us. Within the framework of these procedures, we pledge ourselves to study the Scriptures diligently, to use the Sacraments faithfully, and to solicit the help of the Holy Spirit boldly.

1. NAME

1.1 The name of this corporation is "The Kansas District of The Lutheran Church—Missouri Synod," hereinafter referred to as "the Kansas District" or "the District."

2. ORGANIZATION

2.1 Constitution: The Constitution of The Lutheran Church—Missouri Synod is also the constitution of the Kansas District. The Bylaws of the Synod are also the primary bylaws of the Kansas District.

Legal Representation: The President and Secretary of the District shall sign all official documents of the District in the name of the District.

2.3 Membership: Membership in the Kansas District shall be governed by the Constitution and the Bylaws of the Synod.

2.4 Relationship of the District to the Synod: The relationship of the Kansas District to The Lutheran Church—Missouri Synod shall be governed by the Constitution and Bylaws of the Synod.

2.5 District Conventions: District conventions shall be governed by the Constitution and Bylaws of the Synod and also by the specific articles governing convention procedure as may be defined in these bylaws and the District Operations Manual (which includes position descriptions for Convention Floor Committees, District Convention Planning Committee, Elections Committee, Nominations Committee, Endorsement of Candidates for District Office, and the like).

District Board of Directors: The business and financial affairs of the District shall be governed by the Board of Directors. The Board of Directors oversees the implementation of the strategic mission of the District and is responsible to the District convention to equip, enable, and encourage congregations to proclaim the Gospel. The Board of Directors is vested with the general management and supervision of the District's business and legal affairs and shall adopt policies and require procedures that assure said management and supervision are effected. Between conventions the Board of Directors shall:

- (a) Provide for implementation within the District of decisions of the Synod and District conventions;
- (b) Approve and review progress of work program plans;
- (c) Adopt annual budgets to support work plans;
- (d) Procure and allocate necessary funds for support of Synod and District budgets;
- (e) Review program performance;
- (f) Call or hire District executive staff as deemed appropriate;
- (g) Provide review of executive staff positions; and
 - (h) Administer the District endowment funds and other District funds.

2.7 District Operations Manual: In addition to the Constitution and Bylaws of the Synod and the bylaws of the District, a District Operations Manual shall be established and maintained. This Operations Manual shall specify responsibilities of all officers, boards, and committees, as well as policy statements and operating procedures governing all District functions.

2.8 Geographical Regions: The District shall be divided into geographical regions, each comprised of two (2) or more circuits, by the action of the District convention. A vice-president and a layperson shall be elected to the Board of Directors from each geographic region, and a layperson from each geographic region shall be elected to the District Nominations Committee. The region membership of an individual is determined by the region of the congregation of which he or she is a member.

2. ADMINISTRATION

3.

3.1 Elective and appointive officers shall execute their responsibilities in accordance with Synod Bylaws. These elective and appointive officers shall be:

3.1.1 The District President: The District President shall be elected from the clergy roster of Synod and <u>upon assumption of office</u> shall hold membership in a member congregation of the District. The District President is the chief executive of the District. He shall represent the Synod in the District. He is responsible for implementation of the resolutions of the Synod and the District conventions. The District President serves the congregations of the District as liaison between the congregations, District, and the Synod, and provides leadership and vision for the common work of the congregations, District, and District staff. He is responsible as top staff administrator for oversight of staff carrying out the directives of the Board of Directors. He shall serve as a voting member of the District Board of Directors and is not eligible to be appointed as the

Presiding Officer of the Board meetings. The District President also serves as an ecclesiastical supervisor to congregations and professional workers individual members of the Synod, makes official visits and investigations, and maintains the official roster of workers in the District.

3.1.2 Vice-Presidents: A District Vice-President shall be elected from each region as provided by District Bylaw 2.8. The Vice-Presidents shall be elected from the clergy roster of the District and have membership in a congregation within the region from which they are elected. The Vice-Presidents shall assist the President in administering the overall program of the District, especially in their regions. They shall succeed to the office of President, in the event the President is unable to serve, in the order designated by the convention.

- 3.1.3 Secretary: The District Secretary shall be elected from the clergy roster of the District and shall hold membership in a voting congregation of the District. The District Secretary is responsible for conducting the nominations process for the elections of President and Vice-Presidents, facilitating the work of the Nominations Committee, organizing the work of the Elections Committee, and maintaining the District Operations Manual and related guidelines. The District Secretary is responsible for recording and preserving the official record of actions of the District convention and the Board of Directors.
- 3.1.4 Treasurer: The District Treasurer shall be appointed by the Board of Directors and is the custodian of all money and legal documents of the District. The Treasurer is assisted by the District staff for accounting and preparation of records. The Treasurer shall be a layperson, a member of a voting congregation of the District, and shall demonstrate skills in finance and accounting. The appointment shall run concurrent with District convention, after which reappointment may be granted.
- 3.1.5 Circuit Visitors: A Circuit Visitor for each circuit of the District shall be nominated and elected from the clergy roster of the District as prescribed by the Bylaws of the Synod.
- 3.1.6 The Conference of Circuit Visitors shall assist the District President according to the Bylaws of the LCMS and shall serve as liaison to bring the needs of congregations to the attention of the District President.
- 3.1.7 Presiding Officer of Board meetings: The Board of Directors shall appoint a member of the Board to be the Presiding Officer of the meetings of the Board in consultation with and with the concurrence of the District President. The District President will not normally serve as the Presiding Officer of the Board meetings. In the absence of the Presiding Officer, the District President shall assume the role of Presiding Officer, pro tem.

3.2.2.5 Board of Administration: The Board of Administration provides administrative and support services to the Board of Directors and congregations of the District including accounting, property management, communications, and related services.

3.2.2.6 Executive Committee

- (a) The Executive Committee shall include the District President, Presiding Officer of the Board meetings, the Regional Vice-Presidents, the Chairman of the Circuit Visitors, the Secretary, and the Treasurer. The District President shall serve as chairman of the Executive Committee. The District lead staff, defined as executive and professional staff, are advisors of the Executive Committee. The Executive Committee shall recommend action to the Board on matters that do not fall within the scope of activities of the boards listed above. The Executive Committee is to serve as the coordinating agency of the Board of Directors for meeting preparation, recommendations for appointments, and as a forum for sharing program and budget information with service boards.
- (b) Emergency meetings: The Executive Committee may act for the Board of Directors in times of emergency between meetings and in all matters delegated to it by specific action or by policy of the Board, including response to legal action. The Executive Committee may not perform acts specifically required by statute or by legislation or the Constitution, Bylaws, and resolutions of the Synod that are required to be performed by the Board, nor may they overturn actions of the Board. All Executive Committee actions shall be reported to the Board of Directors. Any member of the Executive Committee may request full Board action on any matter. Minutes of the Executive Committee shall be sent to the Board within two weeks of Committee action. These meetings may be called by the District President, the Presiding Officer of the Board meetings, or three members of the Executive Committee.
- 3.2.2.7 Salary Review Committee: The Salary Review Committee is responsible to the Board of Directors for recommending salaries for the staff positions of the District and recommending guidelines for worker compensation for use by congregations.
- 3.2.2.8 President's Council: The President's Council shall consist of the District President, Vice-Presidents, Secretary, and Chairperson of the Circuit Visitors. The District President may consult with them on ecclesiastical matters as appropriate.

3.2.3 The District Nominations Committee

3.2.4 One member of the Synod's Committee for Convention Nominations when required.

- 3.2.5 The following Service Boards are appointed by the District President in consultation with the Executive Committee and approved by the Board of Directors: Board of Caring Ministry, Board of Stewardship, Board of Education and Youth, Board of Missions, and the Board of Administration.
 - 3.2.6 Standing Committees and Commissions of the Kansas District shall be the Elections Committee, the Congregational Constitution and Bylaw Review Committee, the District Bylaws and Operations Manual Committee, and others described in the District Operations Manual.
 - 3.2.6.1 Members of these standing committees are appointed by the District President and approved by the Board of Directors.
 - 3.2.6.2 Members of these standing committees must be members in good standing of a voting congregation of the Kansas District.

3.2.7 Special Committees

- 3.2.7.1 Special committees shall be such committees as are from time to time necessary for carrying out the duties of the District service boards. Members of these committees are appointed by the District President in consultation with the Executive Committee and are approved by the Board of Directors.
- 3.2.7.2 Members of these committees must be members of a voting congregation of the Kansas District.

3.3 Term of Office

- 3.3.1 The term of office for the President shall be three (3) years. The President shall not serve more than four (4) consecutive terms.
- 3.3.2 The term of office for the Vice-Presidents, Secretary, Circuit Visitors, and the Board of Directors shall be three (3) years. None of these officers shall serve more than three consecutive terms.
- 3.3.3 Service of more than one half (1/2) term in any elected office shall be regarded as a full term.
- 3.3.4 The term of office of the District Nominations Committee shall be three (3) years.

 Members of the Committee may not succeed themselves.
- 984 3.3.5 The term of office of appointive boards, committees, and commissions shall run 985 concurrent with District convention. Due to their responsibilities, the District Youth 986 Ministry Team and the Church Worker Conference Planning Committee are exempt 987 from running concurrent with District convention.

- 988 3.3.6 Members of District boards and commissions shall be ineligible for reelection or reappointment to the same board or commission after serving three (3) consecutive terms unless otherwise provided in the bylaws. They may become eligible again for election or appointment to the same office, board, or commission after an interval of three (3) or more years. More than one half (1/2) term shall be regarded as a full term.
- 3.3.7 Any member of a board or commission who is ineligible for reelection or reappointment may be elected or appointed to another position.
 - 3.3.8 Members of the District staff, while eligible for elective office, shall not serve concurrently as staff and elected officers.
 - **3.4** Accountability of Officers, Boards, Committees, and Commissions: All boards, committees, and commissions shall be responsible to the Board of Directors for the discharge of their responsibilities. Officers in general are responsible to the convention of the District and, as regards ecclesiastical supervision, to the President of the District.
 - 3.5 Holding More than One (1) Elective Office: A nominated candidate, if elected, may not hold more than one (1) office to which he/she was elected. The individual may be considered for a second office, provided it is by official appointment as referenced in the Synod Bylaws. Doubtful cases shall be decided by the President of Synod.
- Succession to the Office of District President: The Vice-Presidents shall, in the order in 3.6 which they have been designated by the District convention, succeed to the presidency in the event the President becomes unable to carry out his duties. Whenever the Board of Directors determines that the President is unable to serve in the capacity because of prolonged illness or disability, the duties and responsibilities of the office of the President shall be assumed by the First Vice-President. The First Vice-President shall remain as the acting President until the Board of Directors determines that the conditions of illness or disability have been removed.

3.7 Vacancies in Elective or Appointive Office

- 3.7.1 In the event of a vacancy in the office of a Vice-President, a successor shall be appointed by the Board of Directors from the region not represented. A Vice-President so appointed shall be last in the order of succession.
- 3.7.2 Vacancies that occur in the office of Circuit Visitor between conventions shall be filled by appointment by the District President.
- 3.7.3 Vacancies in standing committees shall be filled by the District President.
- 1030 3.7.4 Vacancies in the other elective or appointed offices or any other board, special committee, or commission shall be filled by appointment by the Board of Directors. At least one nominee shall be submitted by the Executive Committee. A vacancy in a

position of a regionally elected layperson on the Board of Directors shall be filled with an appointee from that region.

3.8 Appointment of Board Chairpersons: The President shall appoint the chairperson of each service board in consultation with the Executive Committee and with the approval of the Board of Directors.

4. CONVENTION NOMINATIONS AND ELECTIONS

4.1 Nominations Committee: There shall be a District Nominations Committee consisting of three (3) ordained ministers (not more than one [1] from the same region of the District), one (1) commissioned minister, and four (4) laypersons, (one [1] elected from each region of the District). These shall be elected at a regular District convention from the membership of voting congregations. This committee shall propose at least two (2) candidates for each office to be filled at the next District convention except the offices of President, Vice-President, and Circuit Visitor. All incumbents eligible for reelection shall be considered to be nominees. The region membership of an individual is determined by the region of the congregation of which he or she is a member.

4.2 Nominations for District President, Vice-Presidents, Regional Lay Members of the Board of Directors, and Circuit Visitors

4.2.1 District President: Each congregation shall be entitled to nominate one ordained minister as candidate for District President. Candidates for the office of District President shall be on the clergy roster of Synod. Only three individuals receiving the highest number of nominations, and agreeing to serve if elected, may be listed on the convention ballot.

4.2.2 Regional Vice-Presidents: Each congregation shall be entitled to nominate from their region one ordained minister from the clergy roster of the District who shall have membership in a congregation within the region from which he was nominated. Candidates on the ballot for Vice-President from each region shall be all those having been nominated and who agree to serve if elected.

4.2.3 Regional Lay Members of the Board of Directors: Each congregation shall be entitled to nominate two lay members who are members of a congregation in the respective region as a candidate for regional lay member of the Board of Directors. Candidates shall be at least the two lay members in the region who receive the greatest number of nominations and agree to serve if elected. All candidates not elected shall be on the ballot for the at-large lay positions on the Board of Directors.

4.2.4 Circuit Visitor: The selection of Circuit Visitor shall follow the process detailed in the Synod Handbook.

- 1077 4.2.5 District Secretary: Each congregation or individuals (rostered workers and individual members of congregations) may nominate one pastor who is on the clergy roster of the District and holds membership in a voting congregation of the District.
 - 4.2.6 At-Large Lay Members of the Board of Directors: Lay members not designated by region may be nominated by congregations, rostered workers, or individual members of congregations.

4.3 Elections

- 4.3.1 The convention may alter or add to the nominated slates except for the slate for President. A floor nomination must be accompanied by written acceptance of nomination from the nominee and a brief biographical description of the nominee. Material should be provided in digital format when possible.
- 4.3.2 During the convention, the order of elections will be: (1) President, (2) Vice-Presidents, and (3) all other elective positions.
- 4.3.3 A majority of all votes cast shall be required for election to all elective offices and elective board positions. Candidates receiving a majority on the first ballot shall be declared elected.
- 4.3.4 The election of the President shall take place by ballot. If no candidate receives a majority of the votes cast, the candidate receiving the fewest votes shall be eliminated on each subsequent ballot until one candidate receives a majority of the votes cast.
- 4.3.5 The election of the Vice-Presidents shall take place by ballot. If no candidate receives a majority of the votes cast, the candidate receiving the fewest votes shall be eliminated on each subsequent ballot until one candidate receives a majority of the votes cast.
- 4.3.6 Upon the election of the regional Vice-Presidents, a final election shall take place ranking the Vice-Presidents by separate ballots with a simple majority determining the first, second, third and fourth Vice-Presidents in line of succession.
- 4.3.7 Except on the election of the President and the Vice-Presidents, the following regulations shall apply: Candidates receiving a majority on the first ballot will be declared elected. When a second or succeeding ballot is required for a majority, the candidate receiving the fewest votes and all candidates receiving less than 15% of the votes cast shall be dropped from the ballot, unless fewer than two candidates receive 15% or more of the votes cast, in which case the three highest candidates shall constitute the ballot.

5. CONVENTIONS AND CONFERENCES

5.1 District Conventions

- 5.1.2 The regular convention of the District is held in the year immediately preceding the general convention of the Synod. Only the Synod has the right to make an exception to this rule. Each of the parishes/congregations of the District (a multi-congregation parish being considered as a congregational unit) shall be represented by one (1) pastor and one (1) lay delegate duly elected by the congregation at least one hundred fifty (150) days prior to the Convention. Congregations of a multi-congregation parish not contributing a lay voter may send an advisory <u>lay</u> delegate, with voice but no vote, according to the Synod Bylaws.
 - 5.1.3 The vote at all District conventions shall be restricted to the duly elected and certified voting pastors and lay delegates of the congregations. Multi-congregation parishes shall determine the voting lay delegate who shall represent all congregations of that parish. If a congregation or parish has more than one called pastor who is eligible to vote, the congregation shall designate which pastor will cast a vote on behalf of the congregation.
 - 5.1.4 The District convention shall be conducted in accordance with the Synod Handbook. Matters for consideration by the convention shall be presented by overture submitted by a member congregation of the District, the District Board of Directors, an official District conference of ordained and/or commissioned ministers, a committee established by a prior convention, or a forum of a circuit. Resolutions for consideration by the convention shall be brought to the floor of the convention by appointed Floor Committees.

5.2 District Ordained and Commissioned Minister Conferences

5.2.1 Official Conferences

- 5.2.1.1 Districtwide ordained ministers conferences shall be held at least once each year.
- 5.2.1.2 Districtwide commissioned ministers conferences shall be held at least once each year.
- 5.2.1.3 In the odd-numbered years the ordained ministers conference and the commissioned ministers conference shall be held at the same time and in the same city so that both conferences shall be enabled to meet together in joint session at least part of the time. Exceptions may be made by the District President in consultation with the President's Council.

5.2.2 General Regulations

5.2.2.1 Travel, meals, housing, and other expenses for professional workers attending official conferences shall be borne by the congregations of the ordained ministers and commissioned ministers involved.

5.2.2.2 All ordained ministers conferences and commissioned ministers conferences shall be governed by the regulations stated in the Bylaws of the Synod.

- 1170 5.2.2.3 All ordained and commissioned ministers on the District rosters are expected to attend the meeting of their official conference or present a valid excuse.
 - 5.3 Visitation Circuit Forums: The congregations of a visitation circuit, represented by a pastor and one layperson of each member congregation or one layperson from a multi-congregation parish as designated by the congregation or parish, shall meet in circuit forums at least once triennially to select Circuit Visitors, to participate in the triennial process of suggesting mission and ministry emphases to the District convention, and to consider submitting other overtures to the District or Synod convention as described in the Synod Bylaws. In addition, the forum is encouraged to meet at least two times a year to carry out other functions as described in the Synod Bylaws. Congregations of a multi-congregation parish not contributing a lay voter may send an advisory <u>lay</u> delegate, with voice but no vote.
 - **5.4 Electoral Circuit Meetings:** The congregations of a visitation circuit or two adjacent visitation circuits shall meet once triennially to carry out the responsibility of electing delegates to the general convention of the Synod and to consider sending overtures to the Synod convention, according to the Synod Bylaws.
 - 5.5 Circuit Convocations: Circuits of the Kansas District may hold circuit convocations in the year following the Synod convention. Joint convocations of circuits may be held among circuits. The purpose of the circuit convocation is to provide a setting in which congregational members may review and discuss the work of the circuit forum and may receive information on various phases of the work pursued through districts and the Synod. Its emphasis will be on inspiration, education, and motivation.

6. PROPERTY

6.1 This corporation shall have power to acquire by gift, grants, demise, devise, bequest, purchase, or otherwise, property of every kind and description, real, personal, or mixed; to hold and use such property and deal with, or dispose of, any or all such property by sale, exchange, or gift, when necessary or expedient to carry out the objectives of the corporation; provided that all such property shall be acquired, dealt with, or disposed of in a manner not in conflict with the laws of the State of Kansas or the laws of any state in which said property is located.

7. AMENDMENTS AND CHANGES

7.1 Changes in these bylaws and additions thereto may be made provided they are not contrary to the Constitution, Bylaws, and resolutions of the Synod, have received prior approval of the Synod's Commission on Constitutional Matters, are presented to the congregations of the District at least thirty (30) days prior to the time they are presented for vote, are

separately considered and acted upon, and are passed by a majority of the voting delegates at a District convention.

7.2

The District in convention may vote to amend its articles or bylaws provided the resolution is contingent on approval of the Commission on Constitutional Matters. The amended articles or bylaws become effective immediately upon, and only upon, approval of the Commission on Constitutional Matters. Should the Commission on Constitutional Matters not approve the adopted changes, the District Board of Directors may modify amendments to comply with the Commission on Constitutional Matters requirements upon their two-thirds vote.

8. DISTRICT OPERATIONS MANUAL

8.1 Changes to the District Operations Manual that do not affect the Bylaws of the District shall be reviewed and approved by the Board of Directors. The Board of Directors may not adopt any proposed changes to the District Operations Manual that are contrary to the bylaws of the District.

To Recommend and Implement a Rigorous Program of Study in Circuit Winkels

WHEREAS , While it is a blessed fruit of faith of all Christians to "meditate upon [God's] Law day and night" (Ps. 1), it is especially incumbent upon those who serve in the pastoral office to take up this charge, as those given by God to His Bride, the Church, to proclaim and teach His Word and exercise doctrinal oversight in the congregations committed to them; and
WHEREAS , All Christians, but especially the pastors of Christ's Church, should "be always ready to give an answer to everyone who asks you a reason of the hope that is in you" (1 Peter 3:15); and
WHEREAS , Christ's promise of the Holy Spirit's work to "teach you all things and bring all things to your remembrance" (John 14:26) is fulfilled in no other way than through His Word; and
WHEREAS , Paul, providing an example for all called servants of the Word, averred to the Ephesian elders, "I did not shrink from declaring to you the whole counsel of God" (Acts 20:27); and
WHEREAS , "In the presence of God and of Christ Jesus, who will judge the living and the dead," Paul charged Timothy—and all pastors—"preach the Word; be prepared in season and out of season; correct, rebuke and encourage—with great patience and careful instruction" (2 Tim. 4:2); and
WHEREAS , St. Gregory the Great in the foundational pastoral theology of the Western Church asserts: "It is certainly necessary that those who execute the office of preaching do not regress in their study of sacred writ;" and "when a pastor is asked about a spiritual matter by a layperson, it would be disgraceful for him to have to learn the answer, when he should have been prepared to solve the question" (Gregory the Great, <i>The Book of Pastoral Rule</i> (Crestwood; St. Vladimir's Seminary Press, 2007), pp. 84-85); and
WHEREAS , At the 67 th National Convention of The Lutheran Church—Missouri Synod on Wednesday, 24 July 2019, the Synod in convention passed Resolution 6-04 nearly unanimously and by voice vote, "To Support, Encourage, and Expect Continuing Education for all Lutheran Church—Missouri Synod Pastors" (<i>Proceedings of the 2019 (67th) LCMS Convention</i> , p. 45); and
WHEREAS , 2019 Res. 6-04 recognizes that the Synod's desire for enhancing continuing education amongst our pastors has been expressed continuously, though without real fruit, since 1998; and
WHEREAS , 2019 Res. 6-04 resolves that "the Synod fully support, encourage and expect all LCMS pastors to be engaged in continuing education throughout their pastoral ministry from the time of their first call"; and

WHEREAS, 2019 Res. 6-04 furthermore resolves that "congregations be encouraged to support their pastors' continuing education financially and provide the time needed for continuing education"; and

expect all their pastors to be engaged in continuing education"; and

WHEREAS, 2019 Res. 6-04 furthermore resolves that "district presidents encourage, prompt, and

WHEREAS, In the press of pastoral life pastors often find it difficult to maintain a robust study of God's Word and the teachings of Scripture, along with the necessary tools for that study, the use of the biblical languages; and

WHEREAS, In the heyday of the Synodical Conference the pastoral winkels ("Traditional Synodical Conference Winkel Model") provided for:

- the regular, formal study of the Scriptures, led by pastors for pastors;
- the regular, formal study of the Confessions and the Lutheran dogmatic tradition, led by pastors for pastors:
- the regular, formal study of illuminating historical issues and contemporary threats to the teaching of God's Word and our blessed Confession, led by pastors for pastors;
- the regular, formal critique of the teaching and proclamation of the pastors in the winkel; and

WHEREAS, Although the demise of the Traditional Synodical Conference Winkel Model may be attributed to many factors, it has inevitably led to the backgrounding of sound doctrine in the pastoral mind and to a dearth of regularized and formal continuing education; and

WHEREAS, The contemporary, largely unstructured "9 to 12" model of the circuit winkel provides, anecdotally, little professional gain and is often bereft of serious study of God's Word and our blessed Confession; and

WHEREAS, The Circuit Visitors Manual of our Lutheran Church—Missouri Synod (2020) notes that the two primary goals and purposes of the circuit winkel are "Spiritual Development and Enrichment" and "Continuing Education Experiences" (pp. 200-201); and

WHEREAS, Many circuit winkels have become increasingly irrelevant and ineffective in achieving those goals and purposes; and

WHEREAS, The observation in The Circuit Visitors Manual of our Lutheran Church—Missouri Synod (2020) that "the brethren respond with a higher sense of responsibility when a program is structured rather than casual" (p. 202) is borne out by experience; and

WHEREAS, The Circuit Visitors Manual of our Lutheran Church—Missouri Synod (2020) recommends a 9:00 a.m. to 3:00 p.m. or 9:30 a.m. to 3:30 p.m. schedule to provide time for pastors to "present theological papers, do exegesis on a text, prepare sermon studies, and the like" (p. 202); and

WHEREAS, Over against many other forms of continuing education, the Traditional Synodical Conference Winkel Model proves cost-effective by not only involving pastors in the passive reception of the teaching of God's Word and our blessed Confession on a monthly basis, but also in regularly providing pastors with the opportunity actively to mine the sources and in turn teach what they have learned, along with the ability to lay their gleanings before the brothers to verify whether "these things be so" (Acts 17:11); and

WHEREAS, LCMS Kansas District Circuit 6 pastors gathered in winkel have profitably and approvingly used the Traditional Synodical Conference Winkel Model since September of 2019; and

WHEREAS, The LCMS Kansas District pastors of Circuit 6 have been edified by the use of the Traditional Synodical Conference Winkel Model, both in their personal study and in participating in and receiving the teaching and brotherly critique of their peers; and

WHEREAS, The Traditional Synodical Conference Winkel Model generates *koinonia* around the only thing that in Christ's Church can create it—His holy Word and our blessed Confession—but the absence of serious study of that Word and our Confession leads to the rupture of *koinonia*; therefore be it

Resolved, That the District President provide to all circuit visitors and pastors of the LCMS Kansas District a template for the Traditional Synodical Conference Winkel Model which provides, on a monthly basis, for significant and adequate time devoted to: (a) the regular, formal study of God's Word in the original languages led by a circuit pastor; (b) the regular, formal study of our blessed Confession and/or the Lutheran dogmatic tradition led by a circuit pastor; (c) the regular, formal study of an historical, pastoral-theological, or polemical topic led by a circuit pastor; and (d) regular, formal pastor-led critique of the winkel preacher's sermon; and be it further

Resolved, That this convention and the District President provide strong encouragement to circuit visitors and pastors to adopt the Traditional Synodical Conference Winkel Model described above as the regular practice in all circuits; and be it further

Resolved, That the pastors of the LCMS Kansas District be encouraged to embrace the Traditional Synodical Conference Winkel Model and readily, gladly, and energetically to participate in it, for their own theological growth, to maintain the tools of theology in their midst, and to foster *koinonia* in their midst; and be it further

Resolved, That the congregations of the LCMS Kansas District encourage their pastors' robust participation in the study of God's Word and our blessed Confession in their circuit winkels using the Traditional Synodical Conference Winkel Model by providing them with adequate time (for, e.g., personal study and preparation and additional time spent with the circuit pastors in winkel) and sufficient resources (for, e.g., book purchases, travel to winkel); and be it further

Resolved, That the District President report back to this convention in 2025 on the implementation of the Traditional Synodical Conference Winkel Model in the circuits of our district and its reception by and benefit to pastors and congregations alike; and be it finally

Resolved, That this convention memorialize The Lutheran Church—Missouri Synod at the 2023 convention to urge and encourage:

- the district presidents, the executive director of Pastoral Education, the circuit visitors and pastors to adopt the Traditional Synodical Conference Winkel Model in all circuits of The Lutheran Church—Missouri Synod;
- the pastors to embrace and readily, gladly, and energetically to use the Model; and
- the congregations to encourage their pastors' use of the Model by providing them with adequate time and sufficient resources to do the same.

To Develop Biblically Faithful Textbooks/Curricula for Our Day Schools, High Schools, and Home Schools

WHEREAS, Education in all subject areas is first and foremost about what is taught, namely that which is good, true, and beautiful; and

WHEREAS, Secular education in all subject areas is increasingly subject to forces from anti-God, anti-Christ, anti-family, pro-death, amoral, anti-truth, and even anti-beauty perspectives; and

WHEREAS, The Holy Scriptures provide the norm and framework for knowledge in all subject areas, all being interwoven in significant ways with right theology, ethics, history, and human nature as revealed by God therein; and

WHEREAS, The LCMS has the second-largest system of parochial schools in America, but too often they are using secular textbooks/curricula or publications from non-Lutheran traditions; and

WHEREAS, Many Lutheran parents who homeschool their children find good, biblically faithful textbook/curricula options to be sorely lacking; and

WHEREAS, Christian schools and home schools in general would benefit greatly from having more biblically faithful Christian textbook/curricula options; and

WHEREAS, The natural sciences, especially biology and earth sciences, are prone to the grievous errors of Darwinism and Deep Time, which directly undermine the integrity of the Scriptures and the Gospel itself by putting death before the Fall; and

WHEREAS, The Discovery Works science textbooks available from Concordia Publishing House, the only day school curricula available from CPH besides religion curriculum and some lesson plans, are outdated (© 1999) and rather limited (grades 1-6); and

WHEREAS, It was resolved by the Synod in convention in 2019 (Res. 5-09A) "that pastors and other church workers be encouraged to confess, witness to, and uphold in their teaching the Synod's publicly stated positions as set forth in A Brief Statement of the Doctrinal Position of the Missouri Synod, Article 5 (adopted 1932):

We teach that God has created heaven and earth, and that in the manner and in the space of time recorded in the Holy Scriptures, especially Gen. 1 and 2, namely, by His almighty creative word, and in six days. We reject every doctrine which denies or limits the work of creation as taught in Scripture. In our days it is denied or limited by those who assert, ostensibly in deference to science, that the world came into existence through a process of evolution; that is, that it has, in immense periods of time, developed more or less of itself. Since no man was present when it pleased God to create the world, we must look for a reliable account of creation to God's own record, found in God's own book, the Bible. We accept God's own record with full confidence and confess with Luther's Catechism: "I believe that God has made me and all creatures."

WHEREAS, The need is urgent, as common experience shows many young adults rejecting their baptismal vows, their doubts arising in middle school and high school when Darwinism and its many related false "-isms" are proclaimed by secular textbooks, while either no counter arguments for biblical truth are available or those presented are inadequate; and

WHEREAS, The LCMS has a university system and two seminaries housing expertise across all subject areas, for producing excellent curricula and textbooks for grades K-12 as well as providing

WHEREAS, The LCMS has its own publishing house; therefore, be it

Resolved, That the LCMS Kansas District in conjunction with the LCMS Wyoming District (**Res. 1-03-2021**) memorialize the Synod in convention to direct and coordinate the systematic preparation and production of biblically faithful curricula and textbooks across all subject areas, prioritizing biological and earth sciences, for grades K-12 day schools, high schools, and home schools; and be it finally

Resolved, That this curricula be ready for market by 2026.

WHEREAS, Only 26 percent of teachers serving in Lutheran schools are on the active commissioned minister roster of The Lutheran Church—Missouri Synod (LCMS) (2020–2021 Early Childhood and School Statistical Report; www.luthed.org); and

WHEREAS, The LCMS in the 2016 Synod convention adopted Resolution 8-01A, "To Encourage and Strengthen the Lutheran Ethos of Our LCMS Early Childhood Centers, Elementary Schools, and High Schools"; and

WHEREAS, Res. 8-01A specifically identified that a characteristic of a Lutheran school with a strong Lutheran ethos is having "LCMS-trained Lutheran teachers ... who know and are committed to the truths of the Scriptures as declared in our Lutheran Confessions"; and

WHEREAS, The number of new commissioned teachers has declined steadily since 2005 (Concordia University System [CUS] Board for University Education [BUE] statistics); and

WHEREAS, The fulfillment rate of requests for first-year Synod-trained candidates to LCMS calling entities has declined from 63 percent in 2010 to 30 percent in 2018 because of the lack of available Synod-trained candidates (CUS BUE statistics); and

WHEREAS, "The Final Report of the Blue Ribbon Committee on Lutheran Schools" (2019 Synod convention *Workbook*, 343–48) recommended that congregations equip and encourage young Lutherans to become strong Lutheran teachers in academics and in the Christian faith; and

WHEREAS, One of the top factors tied to likelihood to recommend teaching to a young person is support from school administration and Synod ("What's Happening in our Schools?", Concordia Plan Services research); therefore be it

Resolved, That congregations of the LCMS Kansas District be encouraged to aggressively, financially, and publicly support Lutheran administrators and teachers; and be it further

Resolved, That congregations of the LCMS Kansas District and their pastors and teachers, being led by the Holy Spirit, actively encourage future Lutheran school teachers; and be it further

Resolved, That all LCMS Kansas District congregations strongly consider providing financial support through the district scholarship programs as well as direct support for students who are being trained at CUS schools to be Synod-rostered teachers, including at the early education, elementary and secondary levels; and be it finally

Resolved, That the LCMS Kansas District increase the Lutheran identity of our schools by continuing to provide scholarships to enable non-rostered teachers to complete teacher colloquy through the CUEnet program.

WHEREAS, In The Lutheran Church—Missouri Synod (LCMS) in 2020–2021 there were 1,741 early childhood centers, 828 elementary schools, and 97 high schools (2020–2021 The Early Childhood and School Statistical Report, www.luthed.org); and

WHEREAS, As of September 2021, members of the Kansas District are operating 43 early childhood centers with a 2021-22 enrollment of 2,212, and District congregations and associations are operating 14 K-8 schools with a total enrollment of 1,170; and

WHEREAS, The Office of National Mission (ONM) has identified planting schools as a priority for this triennium (2019 Resolution 4-03A); and

WHEREAS, The 2017 *LCMS Study of Young Adults* found that a typical congregation with higher retention rates operated or was associated with a Lutheran school (*Retention of Lutheran Millennials: LCMS Study of Young Adults*, 2017); and

WHEREAS, Early childhood centers, elementary schools, and high schools across the Synod shared the Gospel with over 200,000 students in 2020–2021 (ibid.); therefore be it

Resolved, That all congregations of the LCMS Kansas District be encouraged to support and uplift Lutheran schools in prayer and encourage these schools to continue to be faithful to God's Word and strive for excellence in catechizing and educating the students in their care; and be it further

Resolved, That the LCMS Kansas District staff be directed to distribute materials associated with National Lutherans School Week to all congregations for use in worship; and be it further

Resolved, That the LCMS Kansas District, its circuits, and congregations investigate the possibility of planting schools and early childhood centers; and be it finally

Resolved that the LCMS Kansas District in convention rise and give thanks to God for our Lutheran early childhood centers and elementary schools by singing the doxology.

WHEREAS, Six LCMS Kansas District congregations, including St. Paul Lutheran Church, Clay Center; T.I.G Partnership (Trinity Lutheran Church, Garden City; Grace Lutheran Church, Ulysses; and Immanuel Lutheran Church, Lakin); Christ Lutheran Church, Overland Park; and St. John's Evangelical Lutheran Church, Topeka have been piloting this project since 2020, and it has been well-received by lay leadership, church workers, and care teams and has been regarded as beneficial for the well-being of the congregation; and

WHEREAS, The LCMS Kansas District Board of Directors affirmed the use of the Church Worker Care Manual in Kansas District congregations in 2021; and

WHEREAS, LCMS Kansas District pastors and professional church workers were introduced to the Church Worker Care Manual in the fall of 2021; and

WHEREAS, All 2021 LCMS Kansas District congregation presidents were mailed a copy of the Church Worker Care Manual in October 2021 with encouragement from the LCMS Kansas District President to begin implementing its use with their pastor(s) and other professional church workers on staff (if applicable); therefore be it

Resolved, That lay leaders of LCMS Kansas District congregations be encouraged to implement the Church Worker Care Manual with their pastor(s) and other professional church workers (if applicable) within the 2022-2025 triennium; and be it finally

Resolved, That church worker care teams or other appropriate boards or individuals within the congregation would focus their efforts on praying for, encouraging, and offering respite opportunities (sabbaticals, retreats like Doxology and Grace Place, etc.) for church workers, promoting and supporting financially the continuing education of their called workers, and providing compensation for church workers that meets or exceeds established guidelines in the LCMS Kansas District.
