President Panzer called the meeting to order at 9:00 a.m.

Rev. Scott Snow led our devotions, based upon 1 Thessalonians 5:16-18.

Minutes of the February meeting were approved as distributed.

Resolved, that the LCMS Kansas District Board of Directors approve the Mt. Calvary, Wamego Constitution and Bylaws.

#### Action: Consent Agenda Adopted

Mr. Bradshaw led the Board of Directors in a triennial review. Answers from the group included:

Which activities were most impactful?

The Board's work extends beyond the boardroom into the Church. The amount of information and activities offered by the Kansas District is appreciated. Making connections personally increases the knowledge and aims of the District.

Which priorities were not met?

While the board did much work, and much unexpected work due to the pandemic, we acknowledge we did not finalize options for building use, nor establish new salary guidelines, although time and effort were spent on each of those topics. We may add that we have less personal growth, strategic planning, and community building as a priority due to COVID changes.

What processes can we change?

Ideas brought forth include utilizing service boards to research topics to bring to the board; reviewing the resolutions of the convention quarterly, as all the work is laid before the boards; continued transparency in budgeting, especially restricted/unrestricted funds to promote understanding by the board and the District.

What should we discontinue?

Nothing shows up as ready to be discontinued, but constant review of our tasks is essential in order to provide godly stewardship of our resources. Communication remains vital for feedback and growth for individuals and service boards.

What suggestions/recommendations would you give to the next Board of Directors?

Find joy in the opportunities to work together. Continue to use gifts and talents. Cultivate relationships for the sake of the Church. Many gifts and talents have blessed the District; the future is best viewed by a large-picture approach. Hybrid meetings have been a bonus in preparations for board meeting. The hybrid model has taken away from the personal interactions, as there is less time together.

#### Staff & Board Reports

Rev. Justin Panzer, President, presented his report to the Board of Directors.

Rev. Dan Galchutt, Assistant to the President for Missions and Stewardship, presented his report to the Board of Directors.

Marvin Schulteis, chairman of the Board of Missions, reported concerning mission grants.

He noted three of the 22 grants by highlighting work at St. Andrews, Wichita; Grace, Larned; and Immanuel, Kansas City. While not all grants are highlighted at this meeting, all are appreciated and supported.

Kris Bruss highlighted the current LCMS *Reporter*, which featured the on-the-ground mission work within our Church in its many localities.

Mr. Dan Thalmann, chairman of the Board of Stewardship, noted that the budget receipts and expenses look good after the first quarter. Every Lutheran school in the District has received \$5,000 for outreach and growth from LCEF.

Jim Bradshaw, Assistant to the President for Education and Youth, offered his report to the Board.

Bruce Schultz, Board of Education and Youth chair, reported for the board, and thanked service members and other members of committees who report to this board for their efforts in the extended triennium.

Rick Hanebutt, Board of Caring Ministry chair, reported for the board and highlighted that the work of LERT in Kansas is acknowledged by the Synod. He announced that commissioned workers may attend a free retreat in Wichita, sponsored by Doxology.

Jeff Maltz, LCEF Vice President, offered a written report. In his absence, Rev. Galchutt described the loan process and noted how the District supports congregations, not on the financial side, which comes from LCEF, but on the congregational support side.

Kris Bruss, Communications Specialist, highlighted her printed report. She acknowledged her appreciation for support at the District Office and reported there is a transition underway for the communications position.

Heather Williams, Business Manager, presented her report to the Board of Directors. She also presented the First Quarter Financial Report.

Thad Sullivan, Treasurer, did not add to the written financial reports.

Dave Bruns, chair of the Board of Administration, reported how the board was blessed to provide greater transparency and understanding to the entire Board of Directors and to the District in administering the gifts to the District.

Rev. Bob Grimm, Secretary, reported for Executive Council, Constitution Committee, the Nominations Committee, and the District Bylaws & Operations Manual Committee.

The Salary Review Committee had no report this quarter.

The was no report concerning our unfinished business: District Office tenant (Resolution 21C-01-02).

## Resolution 22B-02-01 – To Board Designate Unspent Funds for Pastors' Wives Retreat

Resolved, that unspent 2022 funds of \$1,240.41 earmarked for Human Care—Pastor's Wives Retreat be moved to a board-designated fund for "Human Care—Pastor's Wives Retreat" for the 2023 year.

Whereas, the Kansas District participated in the soldiers of the cross amplified COVID-19 program in partnership with LCEF and the LCMS; and

Whereas, this program has been discontinued by Synod and \$10,793.10 remains in the KSD board designated account from 2020; therefore, be it

Resolved, that the Kansas District board of directors redesignates the remaining money from that fund to the church worker care fund to continue to help and support church workers in the LCMS Kansas District.

# Resolution 22B-06-03 Request Exception for Circuits 3N and 3S and 9

Whereas, Circuits 3N (3,966 communicants) and 3S (2,567 communicants), each far exceed the required number of aggregate communicant membership requirement, but each are one congregation short of the seven (7) member congregation requirement. (This is caused because the 2nd campuses or satellites of these two circuits are not counted as qualifying.); and

Whereas, the aggregate communicant membership is twice as large as most circuits, giving Circuits 3N and 3S a lower proportionate representation than other circuits; and Whereas, Circuit 9 (1,398 communicants) is 102 communicant members below the requirement of 1500 confirmed members. This number is affected by the vote of closure by Zion, Latimer (55 communicant members) on December 26, 2021. However, the congregation has not officially closed with the state of Kansas. Members have not been transferred to other Circuit 9 congregations yet for procedural and voting purposes of proper closure bringing the total number of communicants for Circuit 9 to 1,453; and

Whereas, recent changes due to the pandemic have greatly impacted communicant numbers. The LCMS Kansas District will be realigning circuits before the next triennium; therefore, be it

Resolved, that the LCMS Kansas District Board of Directors request an exception **to circuit size requirement** of the electoral circuit be granted by the President of Synod to the electoral circuits of 3N and 3S and 9 for the upcoming 2023 convention of Synod.
