### "Here I Stand" Sunday



The Lutheran Church—Missouri Synod will be observing "Here I Stand" Sunday on April 18, 2021, which marks the 500<sup>th</sup> anniversary of Martin Luther's "Here I Stand" moment (pictured above). Per a 2019 LCMS convention resolution, districts, circuits, and congregations are encouraged to commemorate the event and pray that the Lord would continue to bless the proclamation of the gospel.

The LCMS has created materials to help congregations mark the event. Visit the <u>Here I Stand Sunday</u> page, where you'll find a Bible study (with leader and participant guides), bulletin inserts (black-and-white and color), and worship resources, including hymn suggestions, petitions, and sermon connections.

One additional suggestion: Consider marking the day by remembering and reflecting on your confirmation verse. You can find a few examples from our district staff in the Kansas insert of the April Kansas *Lutheran Witness*.

### **COVID-19 Update**

On March 24, Governor Laura Kelly <u>signed into law Senate Bill 40</u>, which modifies the procedure for declaring a state of disaster emergency under the Kansas Emergency Management Act (KEMA). The bill also authorizes the Legislative Coordinating Council and the Legislature to take certain actions related to a state of disaster emergency and prohibits certain actions by the governor related to the COVID-19 health emergency, including issuing an "order that substantially burdens or inhibits the gathering or movement of



individuals or operation of any religious, civic, business or commercial activity, whether for-profit or not-for-profit" (Section 7).

At the time the bill was signed, the governor indicated her intention to reissue some of her previous orders, which were revoked under Senate Bill 40. On April 1, the governor signed a <u>new order</u> requiring face coverings, but the Legislative Coordinating Council revoked the order by a vote of 5-2. Mask requirements are now in the hands of individual counties.

### **Impact on Congregations**

The situation is improving, with COVID-19 cases declining (thanks be to God!) and regulations changing. While this direction is encouraging, opinions are still divided on how best to manage coming out of the pandemic, with some fully supportive of relaxing restrictions, and others concerned that this move is premature.

We encourage you to pay close attention to the situation, especially with respect to local orders and recommendations, and talk to other congregations and schools in similar situations. (Circuit discussions, for example, have proven useful on this front.)

### **District Office Policy**

On March 29, Shawnee County commissioners <u>decided to allow any party to opt out</u> of the county mask requirement. Since our building is large and visitor traffic is light, we have modified our office policy as follows:

Per Shawnee County amendment to resolution 2021-19 (approved March 29, 2021), the Kansas District has elected to make masks optional in our building unless social distancing cannot be maintained. Individual decisions about masks will be respected. We ask that all visitors continue to observe social distancing and other safety recommendations (e.g., use of hand sanitizer, handwashing, monitoring of symptoms). Masks remain available in the building for those meetings and events when social distancing cannot be maintained. If you feel unwell or have recently been exposed to someone with COVID-19, we ask that you postpone your visit.

Thank you for your continued patience during this pandemic. God's peace be with you!



# **Education & Youth**

### **Expansion of Kansas District Middle School Youth Ministry**

In June of 2019, the Kansas District Youth Ministry Task Force surveyed the 160 congregations of the Kansas District to:

- 1. Evaluate the state of youth ministry in LCMS Kansas District congregations.
- 2. Evaluate needs of LCMS Kansas District congregations.
- 3. Determine what the LCMS Kansas District can do to assist LCMS Kansas District congregations in ministering to the youth of Kansas.

The survey results revealed that in recent years, there has been significant growth in District-sponsored middle school events. The survey also pointed to a growing need for these ministry offerings across the District. As a result, the Kansas District Youth Ministry Committee (KDYMC) was tasked with exploring the possibility of expanding Middle School Youth Ministry offerings for the congregations of the Kansas District.

After exploring numerous possibilities, **the KDYMC** is **excited to announce that we are adding new middle school youth offerings**. The KDYMC is forming a middle school confirmation retreat committee which will begin by connecting congregations that are interested in having a confirmation retreat with congregations willing to invite other congregations to join their own confirmation retreats. The committee intends to expand confirmation retreat offerings in the future.



On March 19-20, 22 youth and nine adults from several congregations gathered for the Western Kansas Confirmation Retreat, hosted at Lakeview Christian Camp in Stockton, Kansas. Participating congregations included Messiah, Hays; Redeemer, Atwood; Trinity, Colby; Trinity, Garden City; First, Plainville; and Immanuel, Oakley/Hoxie.

In addition to the confirmation retreats, the KDYMC will launch a Middle School Retreat in the spring of 2022 to be a districtwide, centrally located event. A committee is being formed to plan this event.

The fall "Junior High Rally" (which many of you have heard of) might continue in Western Kansas under the direction of former rostered church worker Leland Jackson through his *Hook, Look, Book LLC*, but it will no longer be a District-sponsored event. Finally, *Higher Things* (an LCMS Recognized Service Organization) is also assisting District congregations by supporting events targeting youth in grades 7– 12. The mission of *Higher Things* is to support the church in passing on the faith by teaching the next generation the Gospel of Jesus Christ. See higherthings.org for additional offerings.

The camp is open to all incoming 9th grade students to graduating seniors. Price per camper is \$450.



Profound insights and practical wisdom. Rev. Dr. John Kleinig's book <u>Grace Upon Grace: Spirituality for Today</u> (CPH) has them both. This book tackles the topic of spirituality for today from a Lutheran perspective. I found this to be especially helpful since many are talking about spirituality in our world today, but often in vague ways. Dr. Kleinig engages this topic in a way that is a real blessing for Lutherans and Lutheran families.

Of first importance, Dr. Kleinig reminds us of that not just our salvation, but also our spirituality, is first and foremost received because of God's grace and Jesus' life, death, resurrection. Dr. Kleinig then builds on this profound truth with practical advice, which includes encouragement to pray out loud, to make use of God's Word by repeatedly saying Bible passages as you meditate upon the Word, and to make God's Word the driving force of your prayers.



There is so much more in this book, which is why I encourage you to pick up a copy of *Grace upon Grace* from Concordia Publishing House. If you do, I am confident that your time in this book will be a blessing for you and for those in your household.

### TRAINING EVENT OPPORTUNITIES

**LERT BASIC TRAINING**: For new teams and existing teams looking for a refresher course with the new curriculum. This is a great opportunity to get a fresh start and expand learning with your LERT teams after a long hiatus. If your congregation is willing to host a regional LERT Basic Training event, please let me know.

**BASIC CHAINSAW SAFETY & OPERATION:** We are hoping to hold at least two Chainsaw Training events this year. If you are interested in participating and becoming **LERT Chainsaw Certified**, please let me know ASAP. A list is being created so that we can measure interest and best location for our events and get dates on the calendar. REMEMBER: If you respond to a disaster with your chainsaw, chainsaw certification is required for you to operate your chainsaw in a disaster response area. This is a requirement of FEMA and OSHA as well as LCMS Disaster Response. LERT certification through LERT Basic Training is required before attending Chainsaw Training.

**TRAIN THE TRAINER:** We need qualified LERT trainers! Is this you? One **Train the Trainer** event will be scheduled in 2021. ### Do You Need to File Form 5578?



**FORM 5578** 

Certificate of Racial Nondiscrimination Does your church operate a preschool? An elementary school? If you answered yes to either question, you are required to submit Form 5578 to the IRS each year. Filing the certificate of racial nondiscrimination is one of the most commonly ignored federal reporting requirements. Churches that operate, supervise or control a private school (including a preschool) must submit Form 5578 each year with the IRS. The deadline for filing is the 15th day of the fifth month following the end of the organization's fiscal year. This is May 15th for those who operate on a calendar year basis. You can obtain a Form 5578 by clicking the link above or by visiting the IRS website at <a href="https://www.irs.gov">www.irs.gov</a>. You can also contact the IRS for forms and publications at 800-829-3676 (800-TAX-FORM).

The Kansas District is offering scholarships to students pursuing a degree in church work at one of the Synod's colleges or seminaries. **The application deadline for 2021-22 scholarships is June 1**. Scholarship amounts are based on available funds and the number of applications received. Awards are sent directly to the college or university.

### A Note from Your DVP



Dear Kansas District Members,

It is my pleasure to represent Lutheran Church Extension Fund (LCEF) and serve the ministries of the Kansas District LCMS. We are blessed with close relationships with district congregations, schools and RSOs.

Is your church in need of repairs or upgrades? If so, we have a great solution. **The Church Improvement Loan** is designed to help churches fund critical church repairs and upgrades. Church improvement loans are limited to LCMS congregations and include:

- Maximum 10-year term
- Up to \$150,000
- 24 months at Cost of Funds (COF) adjusted annually, currently 1.875%
- LCEF COF plus up to 2.5% adjusted annually for remaining term
- Payments fully amortized over term

Church improvement loans can be used on **critical repairs** that can lead to substantial damage and cost if not fixed in a timely manner, **upgrades** that enhance your church's appearance and comfort, and **projects** that improve energy efficiency and save money in the long term.

A couple other programs of interest:

<u>PartnerPLUS</u> is a fixed-rate term note for those who wish to invest even more in the future of the LCMS and its Christ-Centered ministries. Earn 1.625% on amounts up to \$50,000 for the two-year term note and 2.125% on amounts up to \$50,000 for the four-year term note. Available to LCMS individuals, organizations, congregations and Individual Retirement Account investments. Minimum of \$500 to get started.

<u>ConnectPLUS</u> is a fixed-rate term note for new LCEF investors who wish to earn a competitive interest rate while investing in the future of the LCMS and its Christ-centered ministries. Amounts up to \$50,000 earn a 2.125% interest rate. It's now available to congregations and Recognized Service Organizations. Minimum of \$500 to get started.


