President Panzer called the meeting to order at 8:30 a.m. He led our devotions, based upon 1 Peter 2:9–10.

President Panzer gave us a welcome and an update of the status of calls and partnerships in the District.

President Panzer provided the vision for this triennium, based on the 2022 convention theme *Living As the Baptized*. He set goals and expectations for the BOD for this triennium.

The Lead Staff introduced themselves and gave their reports:

- Rev. Dan Galchutt gave an update on church plants in Kansas, Hispanic outreach work, the Guinea seminary fundraiser, and campus ministry coordination.
- Mr. Jeff Maltz gave us information on the loans and investments held by congregations in the District. He reported positive information from LCEF regarding their holdings, interest rate, and outlook for the future. LCEF gave a "double portion" grant to every school in the District.

- Mr. Jim Bradshaw informed us of the commissioned calls within the District, the Educators Worker Conference, and Concordia Academy of Wichita, which is the first Lutheran high school in our District. He gave a positive update on youth ministry, especially following this summer's Youth Gathering. He shared with us everything going on with Parish Education, including Church Worker Care, LERT, and Older Adult Ministry.
- Mrs. Heather Williams gave us her report on the property and accounting of the District.
- Ms. Jackie Schaefer, our new Communications Specialist, shared with us her work on the publications of District, both print (*LW* Kansas insert) and online (emails, website, Facebook).

The Board of Directors were all introduced.

Heather Williams gave an overview of the general business of the BOD, as well as the service boards and their duties.

Bruce Schultz gave an overview of Robert's Rules of Order and the running of the BOD meetings.

Jim Bradshaw shared with us the BOD Code of Conduct.

There was discussion on the work of life ministry in Kansas and the possibility of moving the Life Coordinator position under the Board of Caring Ministry for reporting purposes.

Heather Williams gave an update on the financial dashboard, the balance sheets, the statement of activities, the budget-to-actual tables, and the endowment report.
