DISTRICT STAFF REPORTS

President's Office

Rev. Justin Panzer, District President

Second Quarter Meetings and Events. Events over the second quarter include but are not limited to: multiple meetings, both in-person and virtual, with District staff, President's Council, service boards, and various committees; Constitution & Bylaws Committee meetings; Council of Presidents meetings; 75th District Convention in Salina; LWML National Convention in Omaha, Neb.; LCMS Youth Gathering in New Orleans, La.; Church Worker Care Committee; Older Adult Ministry Committee, and multiple Circuit Winkel visits.

Ordinations and Installations. In the second quarter there were five pastoral installations (Rev. Richard Schneider, Redeemer, Atwood – Region 4; Rev. James Bender, Our Saviour, Kansas City – Region 1; Rev. John Werner, St. John, Palmer – Region 2; Rev. Rocky Mease, Christ, Overland Park – Region 1; Rev. Matthew Vatthauer, St. Paul, Clay Center – Region 2).

Visits/Travel. In the second quarter President Panzer drove 8,952 miles as he traveled to ordinations, installations, meetings, Circuit Winkels, conferences, and preaching engagements.

Congregational Activity. In the second quarter there were eight calling congregations in the Kansas District, with all eight churches seeking a sole pastor. Eight call lists were completed in the past quarter.

Congregational & School Services

Rev. Daniel Grams, Executive Assistant to the President for Congregational & School Services

Missions and Stewardship. Rev. Grams provided updates regarding the LOTW, De Soto and Zion, Concordia church plants, as well as ongoing church planting efforts in Spring Hill and Immanuel, Kansas City, Kan. There is an LCMS International Mission resource available called "Expanding the Spanish Footprint." This resource is available on the District website, https://kslcms.org/missions/mission-fund.

2026 Mission Grant Cycle. The application cycle will start from roughly August 15-September 30. Some additional proposed categories include Partnerships, Schools/Early Childhood Centers, Witness/Outreach Training, Microgrants of \$500 for SEO (article available at https://kslcms.org/missions/mission-fund), and Expanding the Spanish Footprint Training.

Lutheran Schools. Rev. Grams attended multiple meetings in the second quarter, including but not limited to: numerous school visits; commissionings and installations; 75th District Convention in Salina; KAIRS Executive Committee; KLSSF presentations; Early Childhood Conference at Trinity, Shawnee; LCMS Youth Gathering in New Orleans, La.; New Worker Orientation; NLSA National Accreditation Council in St. Louis, Mo., and GOSPEL (LCMS Education Executives) in St. Louis.

Kansas Lutheran Schools Scholarship Foundation. Rev. Grams presented some highlights regarding the KLSSF, including ~\$160,000 available for scholarships. There are 34 students from six of the Kansas District schools who have been qualified for scholarships.

Youth Ministry. The KSD Lutheran Valley Retreat took place June 1-6. The LCMS Youth Gathering was held July 19-23 in New Orleans. The KSD Confirmation Retreat will be held October 3-4 at Rock Springs in Junction City. The KDYG will be held November 14-16 at Rock Springs in Junction City.

Human Resources/Personnel. The Business Office reviewed financial compensation for seven call documents and planning scenarios this quarter.

Property. District Office – The office air conditioning system is failing. It is 26 years old and reliant on R22 freon. District staff are soliciting updates for its replacement. The second floor currently has no air conditioning. The office external doors have also had some concerns as well.

Retreat Center – No significant issues, repairs or improvements this quarter. Due to its potential sale, there will be no new reservations after September 1, 2025. Seller disclosures and photos have been completed, and the listing should be live by the beginning of August.

Accounting/Finance. Congregational giving is beyond year-to-date commitments and came in at 53.12% of annual budget for the second quarter. Expenses are reported at 48.99% of budget. The investment plan that was passed at the 23B Board of

Directors meeting continues to be worked through. There were no LCEF accounts that matured this quarter. The draft budget includes payouts from the 12-quarter rolling market value average for endowments. The 1/15/25 audit is underway and should be completed by September. There was a small net gain on the 2025 Convention financial results.

Stewardship. Planned Giving – Please encourage your congregations and schools to reach out to Heather Williams or Jeffrey Maltz for a presentation. Presentations currently being planned will be held at St. Luke's, Manhattan; Redeemer, Lawrence; Good Shepherd, Marysville, and Hope, Shawnee.

WHEREAS, God created us to care about other people and to help them in their times of need (SC I, Fifth Commandment); and

WHEREAS, Mothers, fathers, and children are a gift from God entrusted to each other's care to form a family and serve Him through their love for each other (Genesis 1:27–28; Ephesians 5:22–6:4; Psalm 127:3); and

WHEREAS, Christians are called "to speak up for those who cannot speak for themselves" (Proverbs 31:8-9); and WHEREAS, The "Value Them Both Amendment" was defeated in the State of Kansas on August 2, 2022, thereby preserving a constitutional right to personal autonomy which includes determining whether to continue a pregnancy thus making the State of Kansas a safe-haven and destination place of abortion for many women in Kansas and surrounding states; and
