President Panzer called the meeting to order at 8:30 a.m. He led our devotions, based upon Isaiah 49:16. He presented his report, noting his meetings, calling congregations, and the students attending and entering seminary.

Pres. Panzer provided the vision for this triennium, based on the 2025 convention theme *Abiding in the Word*. He set goals and expectations for the BOD for this triennium, including the new triennium placemat. He introduced the Board to the work of the District as we serve the members of the Synod in Kansas.

The Lead Staff introduced themselves and gave their reports:

- Rev. Dan Grams described his relatively new position as a combined executive from the last triennium. Regarding missions, he gave an update on church plants and revitalizations in Kansas, Hispanic outreach work, West Africa support, and mission grants. He noted his work on Stewardship, helping with conferences, mission commitments, and planned giving presentations. He gave an update on education and schools and accreditation, including the school genesis projects.
- Mr. Jeff Maltz gave us information on the loans and investments held by congregations in the District. He reported positive information from LCEF regarding their holdings, interest rate, and outlook for the future.

- Mrs. Heather Williams gave us her report on the property and accounting of the District. Congregational giving is above the commitments, at 53.12% of budget, and expenses are reported at 48.99% of budget. She noted her work on planned giving presentations, treasurer workshops, and managing estates.
- Ms. Jackie Schaefer shared with us her work on the publications of District, both print (*Lutheran Witness* Kansas insert) and online (Workers Together newsletter, School Principals newsletter, emails, website, Facebook).

The Board of Directors each introduced themselves.

Mrs. Heather Williams gave an overview of the general business of the BOD, as well as the service boards and their duties.

Dr. Bruce Schultz gave an overview of Robert's Rules of Order and the running of the BOD meetings.

Mrs. Williams shared with us the BOD Code of Conduct.

The BOD recessed while the Executive Committee met for service board assignments.

Staff and service boards gave updates from the afternoon meetings yesterday.

Pres. Panzer explained the consent agenda items, as well as the resolutions under "Unfinished Business" that are resolutions passed by previous Boards that may still be applicable to this Board's work.

Mr. Curt Engelbrecht, chair of the Board of Caring Ministry, presented the report from their meeting yesterday. He emphasized their attention to continuity from the previous triennium. Each of the board members will assist the subcommittees by individually communicating with the chairs of their assigned subcommittees.

Mrs. Williams spoke to the District Retreat Center briefly. The listing has been publicized as of this week. The overall report was received well; there was not much pushback at the District Convention.

Rev. Grams discussed the Scholarship Foundation—its benefits so far and its needs as well. Some schools have been able to receive the max amount for their students, but the general/unrestricted funds are currently low and would need a boost to be able to help students that are not receiving money from restricted donations. He answered questions on the board of the foundation, restrictions, and the nature of the state regulations.

Dr. Schultz, chair of the Board of Education and Youth, delivered its report on Lutheran schools, youth ministry, and parish education. He reported on the appointments to the coordinator positions, which the Board will be acting on, as well as a position description in the District Operations Manual for a Lutheran Schools of Kansas State Accreditation Coordinator.

Mr. Marvin Schulteis, co-chair of the Board of Missions, reported that the mission grant cycle will begin soon. The window for application will be from August 15 to September 30; there will be approximately \$150,000 available to distribute amongst the applicants. The board is looking into offering microgrants of \$500 for Search Engine Optimization and other such outreach opportunities for small town and rural congregations, where these things can go a long way.

Mrs. Williams gave a report on the Education Loan Repayment and Scholarship Committee. They distributed \$60,000 of the possible \$110,000, so the committee is looking for ways to expand their giving opportunities, including funding prospective trips to the Concordias or programs like Christ Academy that could develop interest in church work.

Mrs. Williams presented the 2026 Draft Operating Budget and the Draft Special/Project Budget. We discussed the changes from the current year's budget.

Mr. Brad Brunkow, Treasurer, presented the financial dashboard, the balance sheets, the statement of activities, the budget-to-actual tables, and the financial asset planning sheet. He answered follow-up questions regarding the endowments and the purposes for each.

Hon. Bruns, chair of the combined Boards of Administration and Stewardship, gave its report. He noted the major expense proposal coming from this Board to replace the failing air conditioning units and air handler. The district has received one estimate and is open to other bids to complete the project. There is a time factor to this, because it may take up to thirteen weeks to complete. The board is requesting approval of up to \$140,000 to complete this.

Rev. Joshua Woelmer gave a report on the upcoming Synod convention and the voting and advisory delegates that need to be reported to Synod by October 15, 2025. He gave an update on the Congregational Constitutions & Bylaws Review Committee and the District Bylaws & Operations Manual Committee.

The Executive Committee shared the resolutions they will be bringing before the BOD in New Business.

The Salary Review Committee gave their report, suggesting changes to the Salary Guidelines for 2026, District staff health plans, and District staff payroll.

Whereas, Redeemer Lutheran Church, a.k.a RELM has presented its governing documents and they have been approved by the Constitution and Bylaws Committee and by the congregation members; and

Whereas, Redeemer Lutheran Church has also formally presented its application for membership; and

Whereas, the District President is now presenting these items to the Board of Directors for formal approval; therefore, be it

Resolved, that the LCMS Kansas District Board of Directors approve the Redeemer Lutheran Church Constitution and Bylaws and application for membership; and, be it further

Resolved, that Redeemer Lutheran Church be assigned to Circuit 8 with congregation number 811; and, be it finally

Resolved, that the LCMS Kansas District Board of Directors give thanks to God for this new member congregation of the LCMS Kansas District by standing and singing the Doxology.

The Board stood and sang the Common Doxology in praise for approving the charter of Redeemer Evangelical Lutheran Mission.

Resolution 25C-06-16 - Circuits 4 and 9 Electoral Circuit for the 2026 Synod Convention

Whereas, according to the LCMS Handbook 3.1.2(a), an electoral circuit "shall be determined by the district board of directors"; and

Whereas, Kansas District Bylaw 5.4 says: "Electoral Circuit Meetings: The congregations of a visitation circuit or two adjacent visitation circuits, as determined by the Board of Directors, shall meet once triennially to carry out the responsibility of electing delegates to the general convention of the Synod and to consider sending overtures to the Synod convention, according to the Synod Bylaws."; and

Whereas, the Kansas District Board of Directors requested exception for Circuits 3N and 3S and 4 and 9 at the January 31, 2025 meeting, and the exception for Circuits 4 and 9 was not granted by the Synod President; therefore, be it

Resolved, that the Board of Directors, acting in accord with Bylaw 5.4, make Circuits 4 and 9 an Electoral Circuit for the 2026 Synod Convention with this information shared with the respective Circuit Visitors by the District Secretary.

The health plan will be supplemented by an annual contribution representing the full deductible by the District to a Health Savings Account for those employees enrolled in the CHP.
